Now, Therefore, pursuant to the Constitution and laws of the United States, and the laws of the State of **Minnesota** and the State of **Washington**, I hereby request that **Brandon Lee Kloepfel** be apprehended and delivered to **Michael Carr, Sheriff of Wadena County**, or his designee, who is/are authorized to convey the fugitive to the State of **Minnesota**, there to be dealt with according to law.
