

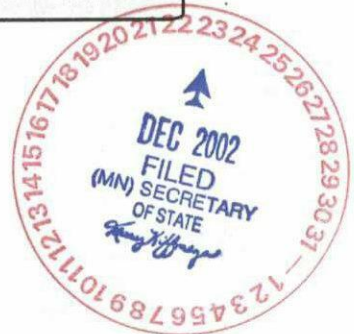

NOW THEREFORE pursuant to the provisions of the constitution and laws of the United States in such case made and provided I do hereby request that **ARTHUR BEN TOLBERT, AKA ARTHUR BEN TOLBERT** be apprehended and delivered to **Rick Wahlberg, Sheriff of St. Louis County, and/or designated agent(s)** who is/are hereby appointed agent(s) to convey him to the State of Minnesota, there to be dealt with according to law.
