
TO HIS EXCELLENCY THE GOVERNOR OF WISCONSIN



Now, Therefore, pursuant to the Constitution and laws of the United States, and the laws of the State of **Minnesota** and the State of **Wisconsin**, I hereby request that **Kevin David McMorrow** be apprehended and delivered to **Cory Aukes, Sheriff of Hubbard County**, and/or authorized designee, who is/are authorized to convey the fugitive to the State of **Minnesota**, there to be dealt with according to law.


