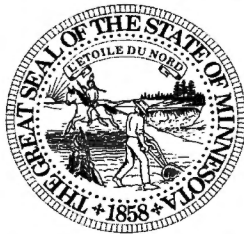

Whereas, it appears by the attached supporting documents, which I certify to be authentic and duly authenticated in accordance with the laws of this State, that **Barbara Jean Elshaug** (the “fugitive”) stands charged by complaint of the crimes of **Felony 5th Degree Controlled Substance Crime – Methamphetamine Possession, Misdemeanor Unlawful Possession of Hypodermic Syringes, and Petty Misdemeanor Possession of Drug Paraphernalia**, which I certify to be crimes under the laws of this State, was present in the State of **Minnesota** at the time of commission of the crimes, fled from justice in the State of **Minnesota**, is now a fugitive, and may now be found in the State of **Wisconsin**;

Now, Therefore, pursuant to the Constitution and laws of the United States, and the laws of the State of **Minnesota** and the State of **Wisconsin**, I hereby request that **Barbara Jean Elshaug** be apprehended and delivered to **Jackie Notch, Jail Administrator of County of Douglas**, and/or authorized designee, who is/are authorized to convey the fugitive to the State of **Minnesota**, there to be dealt with according to law.

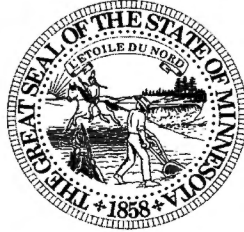
