I have the honor to request that you issue a requisition upon the governor of the State of California for the extradition of Larry James Pinkney, who stands charged by Complaint with the crime of Two Counts of Criminal Sexual Conduct-First Degree committed in the County of Hennepin, State of Minnesota, on September 6, 1992 and September 20, 1992, and who subsequently fled from the jurisdiction of this state and is now a fugitive from justice. I am informed that the accused is within the jurisdiction of the State of California, in the City of Fairfield, is now under arrest, and is in the custody of Albert M. Cardoza, Sheriff of Solano County, at the following address:

530 Union Avenue, Suite 100 Fairfield, CA 94533

Attached to this application and incorporated by reference are certified copies of the Complaints and the warrant of arrest issued thereon, and a copy of the statutes forming the basis for the charges against the accused and defining the punishment.

I hereby certify that the accused was present in this state at the time of the commission of the crimes charged; that in my opinion the ends of justice require that the accused be arrested and returned to the State of Minnesota for trial at public expense; that I am willing such public expense shall be a charge upon the County of Hennepin; and that this application is made in good faith and for the sole purpose of prosecuting the accused for the crimes charged, and not to enforce a private claim.

I nominate Steven Anderson and Gary Charboneau, Deputy Sheriffs of the County of Hennepin in this state, as proper persons to be appointed as agents of the state to receive and return the accused to the State of Minnesota. I certify that the nominees have no personal or private interest in the arrest and return of the accused other than the proper performance of official duty.

COMPLAINT

The Complainant, being duly sworn, makes complaint to the above-named Court and states that there is probable cause to believe that the Defendant committed the following offense(s). The complainant states that the following facts establish PROBABLE CAUSE:

Your complainant, David Denno, is a Sergeant with the Minneapolis Police Department and in that capacity he has reviewed reports and spoken to witnesses. His investigation has revealed the following:

On September 19, 1992, a known adult female, date of birth 11-4-65, was moving into a boarding house located at 3307 University Avenue in Minneapolis, Hennepin County, Minnesota. During the evening hours the known adult female went to the room of another resident, defendant LARRY JAMES PINKNEY. There the two drank wine and discussed the defendant's political activities and looked at numerous newspaper clippings about the defendant's past political activities. During the course of the evening, the defendant told the known adult female that he was going to fuck her and that September 19th was "their day." The known adult female told that defendant that she did not want to have sex with him and tried to leave the The defendant blocked her exit. Shortly after midnight (September 20, 1992), the defendant straddled the known adult female on the couch and began hitting her in the face. The defendant produced a folding knife and held the tip of the blade to her neck. The defendant told the known adult female that he had been trained in the military and could kill her with his bare hands. The defendant undressed the known adult female and penetrated her vagina with his penis.

Fearing for her safety, the known adult female did not try to flee the boarding house until the following morning when her family was expected to come and see her. The defendant slept for some period of time and had forcible vaginal intercourse with her two more times before allowing her to return to her room.

THEREFORE, Complainant requests that said Defendant, subject to bail or conditions of release be:

(1) arrested or that other lawful steps be taken to obtain defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings;

When the victim's family arrived they went to a nearby restaurant to call police. While seated in a squad car at the restaurant, the known adult female observed the defendant in the area. He was later observed in the area of Hennepin County Medical Center when the known adult female was taken there for a sexual assault examination. The defendant called police from a pay phone near the medical center and requested to turn himself in.

A search warrant executed on the defendant's boarding house room and numerous items observed by the victim were observed.

The defendant is not currently in custody.

COMPLAINT

The Complainant, being duly sworn, makes complaint to the above-named Court and states that there is probable cause to believe that the Defendant committed the following offense(s). The complainant states that the following facts establish PROBABLE CAUSE:

Your complainant, Nancy Olson, is a Sergeant with the Minneapolis Police Department and in that capacity she has reviewed reports and witness statements. Her investigation has revealed the following:

On September 5, 1992, a known adult female, date of birth 3-6-74, met with a man known to her as Larry Pinaney, later identified as the defendant LARRY JAMES PINKNEY, on the campus of Macalester College where the woman is a student. The known adult female had spoken to the defendant a few days earlier and had agreed to meet him and talk about political causes in which he was involved. The defendant took the known adult female to his apartment located in a boarding house at 3307 University Avenue in Minneapolis, Hennepin County, Minnesota. While there, the woman observed numerous newspaper articles about the defendant describing him as a The defendant and the known adult female talked for political activist. several hours about her becoming involved in the defendant's "political organization." When the defendant asked the known adult female to spend the night, she declined, indicating that she was not interested in a sexual relationship. The defendant assured her that he only wished to talk so the known adult female agreed to stay.

During the early morning hours of September 6, 1992, the defendant became increasingly demanding and hostile toward the known adult female, grilling her with questions about his political organization, slapping her once when she gave an incorrect answer. At another point, the defendant held a knife to the known adult female's throat and stated, "I could cut your throat if I wanted to." The defendant then ordered the known adult female to undress and get into the fold-out bed in the apartment. The defendant fondled the known adult female's breasts and buttocks and called her names such as

THEREFORE, Complainant requests that said Defendant, subject to bail or conditions of release be:

(1) arrested or that other lawful steps be taken to obtain defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.

"cunt" and "bitch." The victim, crying, begged the defendant to leave her alone. The defendant penetrated the known adult female's vagina with his penis and subsequently forced his penis into her mouth.

Fearing retribution from the defendant, the known adult female remained in the apartment after the defendant fell asleep. When he awoke, the victim asked him to take her home. The defendant became angry and forced her again to submit to vaginal and oral penetration. The defendant later took the defendant back to campus where she immediately reported the rape to her roommate and went to the hospital.

A search warrant executed at the defendant's home revealed many of the items described by the victim in identifying the location of the attack. The known adult female has positively identified the defendant as the person who assaulted her on September 6, 1992.

The defendant is not currently in custody.

That on or about September 6, 1992, in Hennepin County, Minnesota, LARRY JAMES PINKNEY engaged in sexual penetration with a known adult female, date of birth 3-6-74, and circumstances existing at the time of the act caused the known adult female to have a reasonable fear of imminent great bodily harm to herself or another.

609.342 CRIMINAL SEXUAL CONDUCT IN THE FIRST DEGREE. AMENDED

SUBDIVISION 1. Crime defined. A person who engages in sexual penetration with another person is guilty of criminal sexual conduct in the first degree if any of the following circumstances exists:

(c) circumstances existing at the time of the act cause the complainant to have a reasonable fear of imminent great bodily harm to the complainant or another;

SUBD. 2. Penalty. A person convicted under subdivision 1 may be sentenced to imprisonment for not more than 25 years or to a payment of a fine of not more than \$40,000, or both.

609.101 SURCHARGE ON FINES, ASSESSMENTS; MINIMUM FINES. AMENDED

SUBD. 2. Minimum fines. Notwithstanding any other law:

(1) when a court sentences a person convicted of violating section 609.221, 609.267, or 609.342, it must impose a fine of not less than \$500 nor more than the maximum fine authorized by law;

(2) when a court sentences a person convicted of violating section 609.222, 609.223, 609.2671, 609.343, 609.344, or 609.345, it must impose a fine of not less than \$300 nor more than the maximum fine authorized by law; and

(3) when a court sentences a person convicted of violating section 609.2231, 609.224, or 609.2672, it must impose a fine of not less than \$100

nor more than the maximum fine authorized by law.

The court may not waive payment of the fine or authorize payment of it in installments unless the court makes written findings on the record that the convicted person is indigent or that the fine would create undue hardship

for the convicted person or that person s immediate family.

The court shall collect the portion of the fine mandated by this subdivision and forward 70 percent of it to a local victim assistance program that provides services locally in the county in which the crime was committed. The court shall forward the remaining 30 percent to the commissioner of finance to be credited to the general fund. If more than one victim assistance program serves the county in which the crime was committed, the court may designate on a case-by-case basis which program will receive the fine proceeds, giving consideration to the nature of the crime committed, the types of victims served by the program, and the funding needs of the program. If no victim assistance program serves that county, the court shall forward 100 percent of the fine proceeds to the commissioner of finance to be credited to the general fund. Fine proceeds received by a local victim assistance program must be used to provide direct services to crime victims.

The minimum fine required by this subdivision is in addition to the surcharge or assessment required by subdivision 1 and is in addition to any term of imprisonment or restitution imposed or ordered by the court.

As used in this subdivision, "victim assistance program" means victim witness programs within county attorney offices or any of the following programs: crime victim crisis centers, victim-witness programs, battered women shelters and nonshelter programs, and sexual assault programs.
