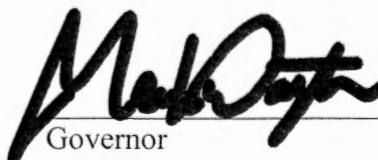
TO HIS EXCELLENCY THE GOVERNOR OF KENTUCKY

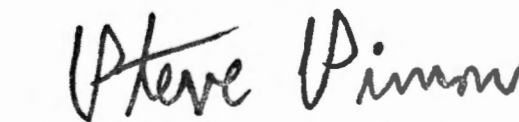

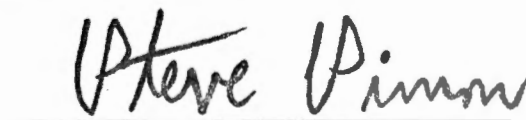
