

Now, Therefore, pursuant to the Constitution and laws of the United States, and the laws of the State of Minnesota and the State of South Dakota, I hereby request that Ryan Lee Foster be apprehended and delivered to Kent Wilkening, Nobles County Sheriff, and/or authorized designee, who is/are authorized to convey the fugitive to the State of Minnesota, there to be dealt with according to law.
