ORDER APPROVING ANNEXATION ORDINANCE

On February 22, 2018, the City of Glenwood (City) adopted a Notice of Intent to Annex pursuant to Minn. Stat. § 414.033, subd. 3 (2016).

No objection by the Minnewaska Town Board (Township) was served pursuant to Minn. Stat. § 414.033, subd. 3.

On July 25, 2018, the City adopted Ordinance Number 16, Third Series (Ordinance) annexing certain real property (Property) legally described as follows:

Parcel 08-0001-000 (Anderson)

- 3. Pursuant to Minn. Stat. § 414.036 (2018), the City will reimburse the Township as stated in Ordinance Number 16.
- 4. The City must file a copy of the Annexation Ordinance with the Township, the appropriate county auditor(s), and the Secretary of State as required by Minn. Stat. § 414.033, subd. 7.
