 Pursuant to Minn. Stat. § 327.32, Subds. 2 and 6, 327.33, 327B.06, 327B.11, and 326B.0981, Subd. 2, authority is hereby granted to the above-noted designee to issue seals for any manufactured home manufactured after July 1, 1972 and prior to June 15, 1976, to issue installation seals for a home that is in compliance with Minnesota Rules Chapter 1350, to perform sufficient inspections of manufacturing premises and manufactured homes to ensure compliance with Minn. Stat. § 327.31 to 327.35, to examine within or outside this state, each dealers' records as necessary to enforce Minn. Stat. § 327B.01 to 327B.12, to review surety claims for manufactured home consumers against manufactured home manufacturers and dealers, to approve continuing education courses and course content, and to assign credit hours for continuing education courses.
