NOW THEREFORE pursuant to the provisions of the constitution and laws of the United States in such case made and provided I do hereby request that the said LANCE LELAND DUKE a/k/a LANCE LELAND WISE be apprehended and delivered to Lt. Terry Stomski of the Minnesota Department of Corrections and/or his agent (s) who is/are hereby appointed agent(s) to convey him to the State of Minnesota, there to be dealt with according to law.
