WHEREAS it appears by complaint, warrant, affidavit and supporting documents, a copy whereof is hereunto attached and which I certify to be authentic and duly authenticated in accordance with the laws of this State, that **LANCE LELAND DUKE a/k/a LANCE LELAND WISE** stands convicted by Judgment and Sentence for the crime of **SIMPLE ROBBERY** committed in the County of Scott in this State, which I certify to be a crime under the laws of this State, he being within this State at the time he committed said crime and who, since conviction and release on supervised release has **FAILED TO ABIDE BY THE TERMS AND CONDITIONS OF HIS PAROLE** and it having been represented and satisfactorily shown to me that said **LANCE LELAND DUKE a/k/a LANCE LELAND WISE**, since the commission of said crime has fled from the justice of this State and now is a fugitive from the justice thereof and may have taken refuge in the State of **MISSOURI**;

NOW THEREFORE pursuant to the provisions of the constitution and laws of the United States in such case made and provided I do hereby request that the said **LANCE LELAND DUKE a/k/a LANCE LELAND WISE** be apprehended and delivered to **Lt. Terry Stomski of the Minnesota Department of Corrections and/or his agent (s)** who is/are hereby appointed agent(s) to convey him to the State of Minnesota, there to be dealt with according to law.
