Whereas, it appears by the attached supporting documents, which I certify to be authentic and duly authenticated in accordance with the laws of this State, that **Brian Christopher Miller** (the "fugitive") was charged by two separate complaints with **felony Threats of Violence in file 46-CR-19-933, and gross misdemeanor Interference of Emergency Telephone Calls and misdemeanor Domestic Assault in file 46-CR-19-926**, of which I certify to be **crimes** under the laws of this State, was present in the State of **Arizona** at the commission of the crime in **file 46-CR-19-933**, which intentionally resulted in a crime in the State of **Minnesota**, was present in the State of **Minnesota** at the time of commission of the crimes in **file 46-CR-19-926**, has fled from justice in the State of **Minnesota**, is now a fugitive, and may now be found in the State of **Arizona**;

Now, Therefore, pursuant to the Constitution and laws of the United States, and the laws of the State of **Minnesota** and the State of **Arizona**, I hereby request that **Brian Christopher Miller** be apprehended and delivered to **Jeff Markquart, Martin County Sheriff**, and/or authorized designee(s), who is/are authorized to convey the fugitive to the State of **Minnesota**, there to be dealt with according to law.
