Whereas, it appears by the attached supporting documents, which I certify to be authentic and duly authenticated in accordance with the laws of this State, that **Stacia Kay Coonradt, a/k/a Stacia Kay Coonradt Kruse, a/k/a Natasha Linn Coonradt, a/k/a Stacia Coonradt, a/k/a Stacia Kruse, a/k/a Stacia K.
