TO HIS EXCELLENCY THE GOVERNOR OF WISCONSIN

Whereas, it appears by the attached supporting documents, which I certify to be authentic and duly authenticated in accordance with the laws of this State, that **Larry Roosevelt Noble a/k/a Edwin Christopher Noble, a/k/a Larry Roosevelt Noble Jr, a/k/a Anthony Stokes, a/k/a Toronto Halliburton** (the “fugitive”) was convicted of **felony Attempted Murder in the Second Degree**, which I certify to be a **crime** under the laws of this State, was present in the State of **Minnesota** at the time of commission of the crime, was placed on supervision, but has since violated the terms of his supervision and has fled from justice in the State of **Minnesota**, is now a fugitive, and may now be found in the State of **Wisconsin**.

Now, Therefore, pursuant to the Constitution and laws of the United States, and the laws of the State of **Minnesota** and the State of **Wisconsin**, I hereby request that the fugitive be apprehended and delivered to **Captain Tim Putzier, Minnesota Department of Corrections**, and/or authorized designee(s), who is/are authorized to convey the fugitive to the State of **Minnesota**, there to be dealt with according to law.
