Resolution 07-2022

Establishing Wards and Establishing Polling Places

WHEREAS, the legislature of the State of Minnesota has been redistricted; and

WHEREAS, Minnesota Statue section 204B.14, subd. 3 (d) requires that ward boundaries must be reestablished within 60 days of when the legislature has been redistricted or at least 19 weeks before the state primary election, whichever comes first;

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Wabasha, County of Wabasha, State of Minnesota, hereby establishes the boundaries of the voting wards and polling places as follows (amending Resolution 11-2012 dated 4-3-2012 and Resolution 536 dated 4-16-2002):

Ward 1 (Fire Hall, 113 Hiawatha Drive West): Excluding Blocks 111, 112, 127, 128, 129, & 148 of Wabasha. Excluding Blocks 15, 16, 17, 18, 31, 32, 33, 34, 35, 39, 40, 41, 42, 54, 55, 56, 57, 65, 66 & 67 of South Wabasha.

Ward 2 (Fire Hall, 113 Hiawatha Drive West): Changes to including Blocks 54 & 67 of South Wabasha.

Ward 3 (Fire Hall, 113 Hiawatha Drive West): changes to include Blocks 111, 112, 127, 128, 129 & 148 of Wabasha; 15, 16, 17, 18, 31, 32, 33, 34, 35, 39, 40, 41, 42, 55, 56, 57, 65, & 66 of South Wabasha.

Attached to this resolution, for illustrative purposes, is a map showing said wards and the central polling place location of Wabasha Fire Hall at 113 Hiawatha Drive West.
