

RESOLUTION NO. 18-22

A RESOLUTION ESTABLISHING CITY ELECTION PRECINCT BOUNDARIES
AND POLLING PLACE

WHEREAS, the United States Department of Commerce, Bureau of the Census, has completed the 2020 official census and the City and other levels of government must necessarily reapportion election district boundaries in compliance with the United States and State Constitutions, the City Charter, and law;

WHEREAS, the City has established new Ward boundaries as required by law and Charter by adopting Ordinance No. 26, Fourth Series.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LUVERNE, MINNESOTA, that in accordance with State law and effective for the 2022 City and State primary election and elections held thereafter, the following election precincts shall be and hereby are established:

Ward Number 1, Precinct 1 (Northeast) shall consist of all that portion of Ward Number 1 lying east of the center lines of the following streets: Commencing at the intersection of Kniss Avenue (U.S. Trunk Highway 75) and Crawford Street, thence north along Kniss Avenue to Barck Avenue, thence east along Barck Avenue to Cedar Street, thence north along Cedar Street to Oakland Avenue, thence west and northerly along Oakland Avenue to Lindale Street, thence westerly and north along Lindale Street to Virginia Street, thence west along Virginia Street to Elm Street, thence north along Elm Street to Veterans Drive, thence west and northerly along Veterans Drive to Kniss Avenue, thence north along Kniss Avenue (U.S. Trunk Highway 75) to the city limits.

Ward Number 1, Precinct 2 (Northwest) shall consist of all that portion of Ward Number 1 which is not located within the afore-described Precinct Number 1.

Ward Number 2, Precinct 1 (Southeast) shall consist of all that portion of Ward Number 2 lying south and east of the center lines of the following streets: Commencing at the intersection of Crawford Street and Kniss Avenue (U.S. Trunk Highway 75), thence south to Luverne Street and Kniss Avenue (U.S. Trunk Highway 75), thence west along Luverne Street to Cottage Grove Avenue, thence south on Cottage Grove Avenue to Main Street (County State Highway Number 4), thence west and southerly along Main Street and Sunshine Avenue (County State Aid Highway Number 4) to the city limits.

Ward Number 2, Precinct 2, (Southwest) shall consist of all that portion of Ward Number 2 which is not located within the afore-described Precinct Number 1.

Upon annexation of any property to the City, said property shall be placed and located within the Precinct to which it is clearly and uniquely adjacent unless the Council by resolution provides otherwise.


BE IT FURTHER RESOLVED, that effective immediately and in accordance with Minnesota Statutes, Section 204 B.16, the polling place for all precincts within the City shall be the Luverne Middle-High School Gymnasium located on Alumni Avenue.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to cause the filing of this resolution and/or related maps and notices to be given and such other acts as are required by law to give effect to this resolution and make such other arrangements as are necessary for the conduct of elections in accordance with the provisions of this resolution.
