

**CITY OF CHASKA  
ORDINANCE MC 2022-1013**

**AMEND CHAPTER 2, ARTICLE 8, SECTIONS 10 AND 20 MN CODE OF  
ORDINANCES**

**WHEREAS**, the legislature of the State of Minnesota has been redistricted; and

**WHEREAS**, Minnesota Statute §204B.14, subd. 3(e) requires that ward boundaries must be reestablished within 60 days of when the legislature has been redistricted or at least 19 weeks before the state primary election, whichever comes first; and

**WHEREAS**, on March 21, 2022, the City Council adopted Ordinance MC 2022-1012, which amended Chapter 2, Article 8, Sections 10 and 20 of the Chaska Minnesota Code of Ordinances to establish the boundaries of the City of Chaska’s voting wards, voting precincts, and polling places; and

**WHEREAS**, Ordinance MC 2022-1012 contained errors in the descriptions of the precinct boundaries that need to be corrected; and

**WHEREAS**, this ordinance repeals error content from the code and reenacts Ordinance MC 2022-1012 in its entirety for the purpose of correcting such precinct boundaries;

**NOW THEREFORE**, be it ordained by the Council of the City of Chaska, in the State of Minnesota, as follows: the Council of the City of Chaska, County of Carver, State of Minnesota, hereby ordains:

**SECTION 1:            REPEAL & REENACT** “2.08.020 Polling Places” of the City of Chaska Municipal Code is hereby *repealed & reenacted* as follows:

**REPEAL & REENACT**

**2.08.020 Polling Places**

- A. *First Ward, Precincts One and Two*: ~~Chaska Event Center located at the northwest corner of Chestnut Street and Chaska Boulevard at 3210 Chaska Boulevard Street in the City of Chaska.~~
- B. *Second Ward, Precincts One and Two*: ~~Christ Victorious Lutheran Church located at the northwest intersection of Pioneer Trail and Shady Oak Drive at 9860 Shady Oak Drive in the City of Chaska.~~
- C. *Third Ward*: Chaska Moravian Church located at the northwest corner of Fourth Street and Walnut Street at 115 Fourth Street East in the City of Chaska.
- D. *Fourth Ward*: Chaska Community Center, located at the intersection of Park Ridge

Drive and Engler Boulevard at 1661 Park Ridge Drive, in the City of Chaska.

**SECTION 2: REPEAL & REENACT** “2.08.010 Ward Boundaries” of the City of Chaska Municipal Code is hereby *repealed & reenacted* as follows:

2.08.010 Ward Boundaries

The Ward boundaries of Wards I, II, III and IV shall be as follows:

**WARD I, Precinct 1**

Beginning at the intersection of the centerline of Chestnut Street and the centerline of U.S. Highway 212; thence northerly along the centerline of Chestnut Street to its intersection with Hundertmark Road; thence westerly along the centerline of Hundertmark Road to its intersection with the centerline of Bavaria Road; thence southerly along the centerline of Bavaria Road to its intersection with the centerline of U.S. Highway 212; thence easterly along the centerline of U.S. Highway 212 to the point of beginning. ~~extended southerly to the centerline of the Minnesota River; thence northerly along the centerline of Chestnut Street to its intersection with Hundertmark Road; thence westerly along the centerline of Hundertmark Road to its intersection with Bavaria Road; thence north along the centerline of Bavaria Road to its intersection with the centerline of Ashley Drive; thence westerly along the centerline of Ashley Drive to its intersection with the easterly property line of Lot 1, Block 1, Tuscany Hills 2nd Addition; thence southerly along the said property line extended south; thence southerly following the centerline of the ditch through wetland EC-W57 to its intersection with Hundertmark Road West; thence westerly along the centerline of Hundertmark Road West to its intersection with the centerline of the Chaska trail which follows the right-of-way of vacated Victoria Drive; thence southeasterly along the centerline of said Chaska trail to its intersection with the centerline of Engler Boulevard; thence westerly along the centerline of Engler Boulevard to its intersection with the west Corporate Limits of the City of Chaska; thence southerly along the west Corporate Limits of the City of Chaska to its intersection with the south boundary line of the Corporate Limits of the City of Chaska; thence east along the south boundary line of the Corporate Limits of the City of Chaska to its intersection with the centerline of the Minnesota River; thence northwesterly and easterly along the centerline of the Minnesota River to the point of beginning.~~

**WARD 1, Precinct 2**

Beginning at the intersection of the centerline of Chestnut Street extended southerly to the centerline of the Minnesota River; thence northerly along the centerline of Chestnut Street to its intersection with the centerline of U.S. Highway 212; thence westerly along the centerline of U.S. Highway 212 to its intersection with the centerline of Bavaria Road; thence northerly along the centerline of Bavaria Road to its intersection with the centerline of Hundertmark Road; thence westerly along the centerline of Hundertmark Road to its intersection with the centerline of Bavaria Road; thence northerly along the centerline of Bavaria Road to its intersection with the centerline of Ashley Drive; thence westerly along the centerline of Ashley Drive to its intersection with the western property line of Lot 1, Block 1, Tuscan Hills 2nd Addition; thence southerly along the said property line extended south; thence southerly following the centerline of the ditch through wetland EC-W57 to its intersection with Hundertmark Road West; thence westerly along the centerline of Hundertmark Road West to its intersection with the centerline of the Chaska trail located upon the vacated right-of-way of Victoria Drive; thence southeasterly along the centerline of said Chaska trail joining upon and continuing southeasterly along the centerline of Victoria Drive over and across U.S. Highway 212 to its intersection with the centerline of Engler Boulevard; thence westerly along the centerline of Engler Boulevard to its intersection with the west Corporate Limits of the City of Chaska; thence southerly along the west Corporate Limits of the City of Chaska to its intersection with the south boundary line of the Corporate Limits of the City of Chaska; thence east along the south boundary line of the Corporate Limits of the City of Chaska to its intersection with the centerline of the Minnesota River; thence northwesterly and easterly along the centerline of the Minnesota River to the point of beginning.

## **WARD II, Precinct 1**

All the territory within the Corporate Limits of the City of Chaska lying north and west of the following described line: Beginning at the intersection of the centerline of Pioneer Trail and the west Corporate Limits of the City of Chaska; thence southeasterly along the centerline of Pioneer Trail to its intersection with the centerline of vacated Victoria Drive; thence southeasterly along the centerline of vacated Victoria Drive to its intersection with the centerline of Twin Cities and Western Railway; thence northeasterly along the centerline of Twin Cities and Western Railway to its intersection with the centerline of McKnight Road; thence northerly along the centerline of McKnight Road to its intersection with the centerline of 82nd Street at the north Corporate Limits of the City of Chaska.

~~Beginning at the intersection of the centerline of Engler Boulevard and the west Corporate Limits of the City of Chaska; thence easterly along the centerline of Engler Boulevard to its intersection with the centerline of the Chaska trail which trail follows the centerline of vacated Victoria Drive; thence northwesterly along the centerline of said Chaska trail to its intersection with the centerline of Hundertmark Road; thence easterly along the centerline of Hundertmark Road to its intersection with the centerline of the ditch through wetland EC-W57; thence northerly along the centerline of the ditch through wetland EC-W57 to the easterly property line of Lot 1, Block 1, Tuscan Hills 2nd Addition; thence northerly along said property line to the centerline of Ashley Drive; thence easterly along the centerline of Ashley Drive to the centerline of Bavaria Road; thence northerly along the centerline of Bavaria Road to its intersection of the centerline of the Twin Cities and Western Railway; thence northeasterly along the centerline of the Twin Cities and Western Railway 14 to its intersection with the centerline of McKnight Road; thence northerly along the centerline of McKnight Road to its intersection with the north Corporate Limits of the City of Chaska; thence northwesterly, westerly, southerly and easterly with the Corporate Limits of the City of Chaska to the point of beginning.~~

## WARD II, Precinct 2

Beginning at the intersection of the centerline of Engler Boulevard and the west Corporate Limits of the City of Chaska; thence easterly along the centerline of Engler Boulevard to its intersection with the centerline of Victoria Drive, thence northwesterly along the centerline of Victoria Drive over and across U.S. Highway 212 joining upon and continuing northwesterly along the centerline of Victoria Drive joining upon and continuing along the centerline of the Chaska trail located upon the vacated right-of-way of Victoria Drive; thence northwesterly along the centerline of said Chaska trail to its intersection with the centerline of Hundertmark Road; thence easterly along the centerline of Hundertmark Road to its intersection with the centerline of the ditch through wetland EC-W57; thence northerly along the centerline of the ditch through wetland EC-W57 to the westerly property line of Lot 1, Block 1, Tuscan Hills 2nd Addition; thence northerly along said property line to the centerline of Ashley Drive; thence easterly along the centerline of Ashley Drive to the centerline of Bavaria Road; thence northerly along the centerline of Bavaria Road to its intersection of the centerline of the Twin Cities and Western Railway; thence southwesterly along the centerline of the Twin Cities and Western Railway to its intersection with the centerline of the vacated right-of-way of Victoria Drive; thence northwesterly along the centerline of vacated Victoria Drive to its intersection with the centerline of Pioneer Trail; thence northwesterly along the centerline of Pioneer Trail to its intersection with the centerline of Clover Ridge Drive at the west Corporate Limits of the City of Chaska; thence southerly along the west Corporate Limits of the City of Chaska to the point of beginning.

### **WARD III**

All the territory within the Corporate Limits of the City of Chaska lying east of the following described line: Beginning at the intersection of the centerline of Chestnut Street extended southerly to the centerline of the Minnesota River; thence northerly along the centerline of Chestnut Street to its intersection with the centerline of Engler Boulevard; thence easterly along the centerline of Engler Boulevard to its intersection with the centerline of Audubon Road; thence northerly along the centerline of Audubon Road to its intersection with the centerline of Pioneer Trail; thence westerly along the centerline of Pioneer Trail to its intersection with the centerline of Acorn Road; thence north along the centerline of Acorn Road to its intersection with the centerline of Autumn Woods Drive; thence northerly and easterly along the centerline of Autumn Woods Drive to its intersection with the centerline of Audubon Road at the east Corporate Limits of the City of Chaska.

~~Beginning at the intersection of the centerline of Chestnut Street extended southerly to the centerline of the Minnesota River; thence northerly along the centerline of Chestnut Street to its intersection with the centerline of Engler Boulevard; thence easterly along the centerline of Engler Boulevard to its intersection with the centerline of Audubon Road; thence northerly along the centerline of Audubon Road to its intersection with the centerline of Pioneer Trail; thence westerly along the centerline of Pioneer Trail to its intersection with the centerline of Acorn Road; thence north along the centerline of Acorn Road to its intersection with the centerline of Autumn Woods Drive; thence northerly and westerly along the centerline of Autumn Woods Drive to its intersection with the the Corporate Limits of the City of Chaska; thence southerly, easterly, westerly, northeasterly and southerly along the east Corporate Limits of the City of Chaska to its intersection with the centerline of the Minnesota River; thence~~

~~southerly and westerly along the centerline of the Minnesota River to the point of beginning.~~

#### **WARD IV**

Beginning at the intersection of the centerline of Engler Boulevard and the centerline of Chestnut Street; thence northerly along the centerline of Chestnut Street to its intersection with the centerline of Hundertmark Road; thence westerly along the centerline of Hundertmark Road to its intersection with the centerline of Bavaria Road; thence northerly along the centerline of Bavaria Road to its intersection with the centerline of the Twin Cities and Western Railway; thence northeasterly along the centerline of the Twin Cities and Western Railway to its intersection with the centerline of McKnight Road; thence northerly along the centerline of McKnight Road to its intersection with 82nd Street at the north Corporate Limits of the City of Chaska; thence easterly along the centerline of 82nd Street and continuing to the northeast corner of Lot 2 Block 1 of Arbor Park 3rd Addition, thence southerly along the eastern boundary of Lot 2, Block 1 of Arbor Park 3rd Addition along the east Corporate Limits of the City of Chaska to the intersection with the centerline of the Twin Cities and Western Railway; then northwesterly to its intersection with the centerline of Lyman Boulevard; thence southeasterly along the centerline of Lyman Boulevard to its intersection with Lake Hazeltine Drive; thence southeasterly along the northern boundary of Tract O as depicted on Registered Land Survey No. 51, Carver County, Minnesota and continuing along the northern boundary of the eastern property to its intersection with the centerline of Audubon Road; thence southerly along the centerline of Audubon Road to its intersection with the centerline of Autumn Woods Drive; thence westerly and southerly along the centerline of Autumn Woods Drive to its intersection with the centerline of Acorn Road; thence southerly along the centerline of Acorn Road to its intersection with the centerline of Pioneer Trail; thence easterly along the centerline of Pioneer Trail to its intersection with the centerline of Audubon Road; thence southerly along the centerline of Audubon Road to its intersection with the centerline of Engler Boulevard; thence westerly along the centerline of Engler Boulevard to the point of beginning.

~~Beginning at the intersection of the centerline of Engler Boulevard and the centerline of Chestnut Street; thence northerly along the centerline of Chestnut Street to its intersection with the centerline of Hundertmark Road; thence westerly along the centerline of Hundertmark Road to its intersection with the centerline of Bavaria Road; thence northerly along the centerline of Bavaria Road to its intersection with the centerline of the Twin Cities and Western Railway; thence northeasterly along the centerline of the Twin Cities and Railway Western No. 14 to its intersection with the centerline of McKnight Road; thence northerly along the centerline of McKnight Road to its intersection with the north Corporate Limits of the City of Chaska; thence easterly, northerly and southerly along the northerly and easterly Corporate Limits of the City of Chaska to its intersection with the centerline of Autumn Woods Drive; thence westerly and southerly along the centerline of Autumn Woods Drive to its intersection with the centerline of Acorn Road; thence southerly along the centerline of Acorn Road to its intersection with the centerline of County Road No. 14; thence easterly along the centerline of Pioneer Trail intersection with the centerline of Audubon Road; thence southerly along the centerline of Audubon Road to its intersection with the centerline of Engler Boulevard; thence westerly along the centerline of Engler Boulevard to the point of beginning.~~




