

ORDINANCE O2022-007
AN ORDINANCE OF THE CITY OF SHAKOPEE, MINNESOTA AMENDING CITY CODE
CHAPTER 2, SECTION 32.01 PRECINCT BOUNDARIES

THE CITY COUNCIL OF THE CITY OF SHAKOPEE, MINNESOTA ORDAINS:

SECTION 1: City Code Section 32.01 is amended to read as follows:

- A. *First Precinct.* The First Precinct shall be bounded on the west and north by the corporate City Limits; on the east by Market Street, and its northerly extension, extending from Tenth Avenue to the northern corporate City Limits; and on the south by a line described as beginning at the intersection of Tenth Avenue and Market Street; thence west along said Tenth Avenue to Adams Street; thence north along said Adams Street to Sixth Avenue; thence southwesterly along Sixth Avenue to Tenth Avenue; thence southwesterly along said Tenth Avenue to the western corporate City Limits and there terminating.
- B. *Second Precinct.* The Second Precinct shall be bounded on the south by Vierling Drive; on the north by the northern corporate City Limits; on the west by a line described as beginning at the intersection of Vierling Drive and Spencer Street; thence north along said Spencer Street to Tenth Avenue; thence east along said Tenth Avenue to Market Street; thence north along said Market Street, and its northerly extension, to the northern corporate City Limits and there terminating; and on the east by a line described as beginning at the intersection of Vierling Drive and Marschall Road (County Road 17); thence north along said Marschall Road (County Road 17) to Fourth Avenue; thence East along said Fourth Avenue to Viking Steel Road; thence north along said Viking Steel Road to County Road 101; thence west along said County Road 101 a distance of 1100 feet more or less to a meandering creek; thence northerly and easterly along said meandering creek to the northern corporate City Limits and there terminating.
- C. *Third Precinct.* The Third Precinct shall be bounded on the north by County Road 101; on the east by Canterbury Road (County Road 83); on the south by U.S. Highway 169; on the southwest by Eagle Creek Boulevard; and on the west by Sarazin Street and Viking Steel Road.
- D. *Fourth Precinct.* The Fourth Precinct shall be described as follows: beginning at the intersection of County Road 101 and Canterbury Road (County Road 83); thence south along said Canterbury Road (County Road 83) to U.S Highway 169; thence easterly along said U.S. Highway 169 to the outlet channel of Dean Lake; thence southerly, westerly, and southerly along said outlet channel to the north shore of said Dean Lake; thence southeasterly and southerly along said north shore of Dean Lake to the inlet channel of said Dean Lake; thence easterly along said inlet channel of Dean Lake to County Road 21; thence northeasterly along said County Road 21 and State Highway 13 to the eastern corporate City Limits; thence north along said eastern corporate City Limits to the northern corporate City Limits; thence west along said northern corporate City Limits to a meandering creek (said creek is described as beginning at a point 1100 feet more or less west of Viking Steel Road on County Road 101; thence northerly and easterly along said meandering creek to the northern corporate City Limits); thence westerly and southerly along said meandering creek to a point

on County Road 101 (said point being 1100 feet more or less west of Viking Steel Road); thence easterly along said County Road 101 to the point of beginning and there terminating.

- E. *Fifth Precinct.* The Fifth Precinct shall be described as follows: beginning at the intersection of Adams Street and Sixth Avenue; thence southwesterly along said Sixth Avenue and Tenth Avenue to the western corporate City Limits; thence southerly along said western corporate City Limits to the south line of Section 11, Township 115 North, Range 23 West; thence east along said south line of Section 11 and the south line of Section 12, Township 115 North, Range 23 West to Fuller Street; thence north along said Fuller Street to Vierling Drive; thence westerly along said Vierling Drive to Adams Street; thence north along said Adams Street to the point of beginning and there terminating.
- F. *Sixth Precinct.* The Sixth Precinct shall be bounded on the north by Tenth Avenue; on the east by County Road 79; on the south by the southern corporate City Limits; and on the west by a line described as beginning at the intersection of Tenth Avenue and Adams Street; thence south along said Adams Street to Vierling Drive; thence easterly along said Vierling Drive to Fuller Street; thence south along said Fuller Street to the south line of Section 12, Township 115 North, Range 23 West; thence west along said south line of Section 12 to Marystown Road; thence south along said Marystown Road to the southern corporate City Limits and said line there terminating.
- G. *Seventh Precinct.* The Seventh Precinct shall be bounded on the north by Vierling Drive; on the east by Marschall Road (County Road 17); on the west by County Road 79; and on the south by a line described as beginning at the intersection of Marschall Road (County Road 17) and Valley View Road; thence westerly and northerly along said Valley View Road to Seventeenth Avenue; thence west on said Seventeenth Avenue to County Road 79 and said line there terminating.
- H. *Eighth Precinct.* The Eighth Precinct shall be bounded on the north by Fourth Avenue; on the east by Sarazin Street; on the northeast by Eagle Creek Boulevard; on the south by U.S. Highway 169; and on the west by Marschall Road (County Road 17).
- I. *Ninth A Precinct.* The Ninth A Precinct shall be described as that part of the following which lies within House District No. 54A: beginning at the intersection of County Road 79 and Seventeenth Avenue; thence east along said Seventeenth Avenue to Valley View Road; thence southerly and easterly along said Valley View Road to Marschall Road (County Road 17); thence south along said Marschall Road (County Road 17) a distance of 1000 feet more or less to the westerly extension of Valley View Road; thence southeasterly along said westerly extension and Valley View Road to the east line of the West Half of the Northeast Quarter of Section 20, Township 115 North, Range 22 West; thence south along said east line of the West Half of the Northeast Quarter and the east line of the West Half of the Southeast Quarter of said Section 20 to County Road 42; thence east along said County Road 42 to the eastern corporate City Limits; thence southerly along said eastern corporate City Limits to the southern corporate City Limits; thence westerly along said southern corporate City Limits to the western corporate City Limits; thence northerly along said western corporate City Limits to the northeast corner of Jackson Township; thence continue northerly along said County Road 79 to the point of beginning and there terminating.

- J. *Ninth B Precinct.* The Ninth B Precinct shall be described as that part of the following which lies within House District No. 54B: beginning at the intersection of County Road 79 and Seventeenth Avenue; thence east along said Seventeenth Avenue to Valley View Road; thence southerly and easterly along said Valley View Road to Marschall Road (County Road 17); thence south along said Marschall Road (County Road 17) a distance of 1000 feet more or less to the westerly extension of Valley View Road; thence southeasterly along said westerly extension and Valley View Road to the east line of the West Half of the Northeast Quarter of Section 20, Township 115 North, Range 22 West; thence south along said east line of the West Half of the Northeast Quarter and the east line of the West Half of the Southeast Quarter of said Section 20 to County Road 42; thence east along said County Road 42 to the eastern corporate City Limits; thence southerly along said eastern corporate City Limits to the southern corporate City Limits; thence westerly along said southern corporate City Limits to the western corporate City Limits; thence northerly along said western corporate City Limits to the northeast corner of Jackson Township; thence continue northerly along said County Road 79 to the point of beginning and there terminating.
- K. *Tenth Precinct.* The Tenth Precinct shall be bounded on the north by U.S. Highway 169; on the east by Canterbury Road (County Road 83); on the west by Marschall Road (County Road 17); on the south by a line described as beginning at the intersection of Canterbury Road (County Road 83) and Seventeenth Avenue; thence west along said Seventeenth Avenue to Brittany Drive; thence south along said Brittany Drive to French Trace Avenue; thence East along said French Trace Avenue to Quail Drive; thence south along said Quail Drive to Groveland Way; thence westerly along said Groveland Way to Saint Francis Avenue; thence northwesterly and westerly along said Saint Francis Avenue to Sarazin Street; thence south along said Sarazin Street a distance of 750 feet more or less to Valley View Road East;; thence west along said Valley View Road East to Marschall Road (County Road 17) and there terminating.
- L. *Eleventh Precinct.* The Eleventh Precinct shall be bounded on the north by Seventeenth Avenue; on the east by Canterbury Road (County Road 83); on the south and west by a line described as beginning at the intersection of Canterbury Road (County Road 83) and Thrush Street; thence west along said Thrush Street to Pheasant Run Street; thence south along said Pheasant Run Street to Valley View Road; thence northwesterly along said Valley View Road and its westerly extension to Marschall Road (County Road 17); thence north along said Marschall Road (County Road 17) a distance of 1000 feet more or less to Valley View Road East; thence east along said Valley View Road East to Sarazin Street; thence north along said Sarazin Street to Saint Francis Avenue; thence easterly and southeasterly along said Saint Francis Avenue to Groveland Way; thence easterly along said Groveland Way to Quail Drive; thence north along said Quail Drive to French Trace Avenue; thence west along said French Trace Avenue to Brittany Drive; thence north along said Brittany Drive to Seventeenth Avenue and said line there terminating.
- M. *Twelfth A Precinct.* The Twelfth A Precinct shall be bounded on the east by the eastern corporate City Limits; on the south by the southern corporate City Limits; on the west, northwest, and north by a line described as beginning at the intersection of Pike Lake Road South and the southern corporate City Limits; thence north along said Pike Lake Road South to Eagle Creek Boulevard (County Road 16); thence northwesterly along said Eagle Creek Boulevard (County Road 16) to County Road 21; thence northeasterly along said County

Road 21 and State Highway 13 to the eastern corporate City Limits and said line there terminating.

- N. *Twelfth B Precinct.* The Twelfth B Precinct shall be described as follows: beginning at the intersection of the southern corporate City Limits and Canterbury Road (County Road 83); thence north along said Canterbury Road (County Road 83) to U.S Highway 169; thence easterly along said U.S. Highway 169 to the outlet channel of Dean Lake; thence southerly, westerly, and southerly along said outlet channel to the north shore of said Dean Lake; thence southeasterly and southerly along said north shore of Dean Lake to the inlet channel of said Dean Lake; thence easterly along said inlet channel of Dean Lake to County Road 21; thence southwesterly along said County Road 21 to Eagle Creek Boulevard (County Road 16); thence southeasterly along said Eagle Creek Boulevard (County Road 16) to Pike Lake Road South; thence south along said Pike Like Road South and its southerly extension to the southern corporate City Limits; thence westerly along said southern corporate City Limits to the point of beginning and there terminating.
- O. *Thirteenth Precinct.* The Thirteenth Precinct shall be bounded on the north by the north line of Section 14, Township 115 North, Range 23 West; on the east by Marystown Road; on the south by the southern corporate City Limits; and on the west by the western corporate City Limits.
- P. *Fourteenth Precinct.* The Fourteenth Precinct shall be described as follows: beginning at the intersection of Canterbury Road (County Road 83) and Thrush Street; thence west along said Thrush Street to Pheasant Run Street; thence south along said Pheasant Run Street to Valley View Road; thence southeasterly along said Valley View Road to the west line of the East Half of the Northeast Quarter of Section 20, Township 115 North, Range 22 West; thence south along said west line of the East Half of the Northeast Quarter and the west line of the East Half of the Southeast Quarter of said Section 20 to County Road 42; thence east along said County Road 42 to the eastern corporate City Limits; thence north along said eastern corporate City Limits to the southern corporate City Limits; thence east along said southern corporate City Limits to Canterbury Road (County Road 83); thence north along said Canterbury Road (County Road 83) to the point of beginning and there terminating.
- Q. *Generally.* Unless otherwise specified in this section, all precinct boundaries that reference avenues, drives, roads, streets, and highways means the centerline of such avenues, drives, roads, streets, and highways.

SECTION 2: Summary Approved. The City Council hereby determines that the text of the summary ordinance marked "Official Summary of Ordinance O2022-007", a copy of which is attached hereto, clearly informs the public of the intent and effect of the ordinance. The Council further determines that publication of the title and such summary will clearly inform the public of the intent and effect of the ordinance.

SECTION 3: Posting and Filing. A copy of this ordinance is filed in the office of the City Clerk and a copy is provided to the Shakopee Library for posting and filing, at which locations a copy is available for inspection by any person during regular office hours.

SECTION 4: The City Clerk shall publish the title of this ordinance and the official summary in the official newspaper with notice that the printed copy of the ordinance is available for inspection by any person during regular office hours at the office of the City Clerk and Shakopee Library.

SECTION 5: Effective Date: This ordinance becomes effective from and after its passage and publication.
