# RESOLUTION APPROVING THE CITY OF MANKATO WARD REDISTRICTING PLAN

WHEREAS, Minnesota Statute § 204B.135 allows cities that elect council members by wards to redistrict those wards only after the legislature has been redistricted in a year ending in one or two, 60 days following the legislative redistricting no later than 19 weeks before the state primary election, March 29, 2022 whichever is first; and

WHEREAS, the Minnesota Legislature was redistricted on February 15, 2022; and

WHEREAS, city wards are expected to be as equal in population as possible, compact and contiguous in shape, contain communities of interest, offer political competitiveness and provide an equal opportunity for representation; and

WHEREAS, when reviewed by city staff with the 2020 census numbers, the wards in the City of Mankato were disproportionate; and

WHEREAS, a redistricting plan which redraws the boundaries of the city's wards has been presented so that they are in compliance with the expectations listed above.

NOW THEREFOR BE IT RESOLVED by the City Council of the City of Mankato that the wards for the City of Mankato, as illustrated on the attached map, are hereby established.



# RESOLUTION DESIGNATING PRECINCTS AND POLLING PLACE LOCATIONS FOR PRECINCTS FOR THE CITY OF MANKATO

WHEREAS, Minnesota Statute 204B.14, states that precinct boundaries must be reestablished within 60 days of the time when the legislature has been redistricted or at least 19 weeks before the state primary election, whichever comes first; and

**WHEREAS**, Minnesota Statute 204B.16, states that by December 31 of each year, the governing body of each municipality must designate polling places for each election precinct for elections in the following calendar year; and

WHEREAS, Minnesota Statute 204B.14, states that within 30 days of establishing precinct boundaries as a result of redistricting or at least 19 weeks before the state primary election in a year ending in two, whichever comes first, the governing body of each municipality must designate polling places for each election precinct; and

WHEREAS, the City of Mankato has the ability to change the polling location mid-year for an emergency per Minnesota Statute 204B.175, or if a polling place has become unavailable. If the location of a polling place is changed, the city will send to every affected household with at least one registered voter in the precinct, a non-forwardable mailed notice stating the location of the new polling place at least 25 days before the next election.

**NOW THEREFORE BE IT RESOLVED** by the City Council for the City of Mankato, County of Blue Earth, and State of Minnesota that the attached listing of precincts and polling locations for 2022 be and hereby are adopted.

This resolution shall become effective upon its passage and without further publication.


