

CITY OF NORTHFIELD, MN
CITY COUNCIL RESOLUTION 2022-027
REESTABLISHING PRECINCTS AND POLLING PLACES

WHEREAS, the legislature of the State of Minnesota has been redistricted; and

WHEREAS, Minnesota Statutes, section 204B.14, subd. 3 (d) requires that precinct boundaries must be reestablished within 60 days of when the legislature has been redistricted or at least 19 weeks before the state primary election, whichever comes first.

NOW, THEREFORE BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL THAT the City of Northfield, Counties of Rice/Dakota, State of Minnesota hereby reestablishes the boundaries of the voting precincts and polling places as follows:

Ward 1, Precinct 1 (First United Church of Christ, 300 Union Street)

That portion of Ward 1 that is north of Woodley Street E., west of Maple Street S., and north of Wall Street Road

Ward 1, Precinct 2 (St. Peter's Lutheran Church, 418 Sumner Street E.)

That portion of Ward 1 that is south of Woodley Street E., east of Maple Street S., and south of Wall Street Road.

Ward 2, Precinct 1 (United Methodist Church, 1401 Maple Street S.)

That portion of Ward 2 that is east of Division Street, north of Jefferson Parkway and east of Highway 3.

Ward 2, Precinct 2 (Northfield Community Resource Center, 1651 Jefferson Parkway)

That portion of Ward 2 that is west of Division Street, south of Jefferson Parkway and west of Highway 3

Ward 3, Precinct 1 (Emmaus Baptist Church, 712 Linden Street North)

That portion of Ward 3 that is south of the Rice County/Dakota County line

Ward 3, Precinct 2 (Bethel Lutheran Church, 1321 North Avenue)

That portion of Ward 3 that is north of the Rice County/Dakota County line

Ward 4, Precinct 1 (St. John's Lutheran Church, 500 Third Street W.)

That portion of Ward 4 that is south of Fifth Street, south of Forest Avenue and east of Lincoln Street.

Ward 4, Precinct 2 (St. Olaf College Buntrock Commons, 1520 St. Olaf Avenue)

That portion of Ward 4 that is north of Fifth Street, north of Forest Avenue and west of Lincoln Street.

BE IT FURTHER RESOLVED THAT attached to this resolution as Exhibit A, for illustrative purposes, is a map showing said precincts and the location of each polling place as the same exist in

the respective City wards, which wards are hereby confirmed, as said wards now exist pursuant to Northfield City Code, Chapter 2, Article I, Division 1, Section 2-1.

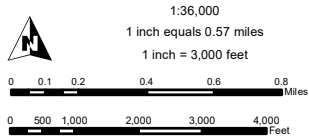
