

ORDINANCE NO 4465

AN ORDINANCE REPEALING IN WHOLE AND REPLACING
 WITH A NEW CHAPTER 2-2 OF TITLE 2 OF THE ROCHESTER
 CODE OF ORDINANCES RELATING TO WARD BOUNDARIES.

THE COMMON COUNCIL OF THE CITY OF ROCHESTER ORDAINS:

Section 1. Chapter 2-2 of Title 2 of the Rochester Code of Ordinances is hereby repealed and replaced to read as follows:

Sec. 2-2-1. Ward boundaries established.

Pursuant to the provisions of the city Charter, and based upon the official certified United States 2010 2020 Decennial Census of the city, the boundaries of the various wards of the city are hereby determined and established as follows in this chapter.

Sec. 2-2-2. First ward.

Ward 1 encompasses all parts of the city south of the following described line: ~~beginning at the western city limits on Salem Road SW; thence north and east along the city limits to West Circle Drive SW; thence south along West Circle Drive SW to its intersection with Salem Road SW; thence east along Salem Road SW to its intersection with 12th Street SW; thence east along 12th Street SW to its intersection with South Broadway; thence east along 12th Street SE to 11th Avenue SE; thence south along 11th Avenue SE to its crossing of Willow Creek; thence northeasterly along Willow Creek to its confluence with Bear Creek; thence easterly (upstream) along Bear Creek to its intersection with the boundary between Legislative Districts 26A and 26B; thence north and east along the boundary between Legislative Districts 26A and 26B to Marion Road SE; then southeasterly along Marion Road SE to the city limits. Future annexations of territory now in Rochester Township, in Marion Township south of Marion Road SE, and in High Forest Township will be added to Ward 1~~ beginning at the northwest corner of Lot 1, Block 1, Bamber Valley Estates Third; thence easterly to the east line of the intersection of Valleyview Rd SW and 34th Ave SW; thence continuing east along the south line of Lot 2, Block 1, Orchard Acres First Subdivision; thence along the southerly line of Historic Hill Subdivision and continuing easterly across West Circle Drive SW and continuing easterly along Fox Valley Dr SW to the intersection of Salem Road SW; thence northeast along Salem Road SW until it becomes Trunk Highway 14 / 12th St SW; thence easterly along Trunk Highway 14 / 12th St SW to its intersection of 3rd Ave SE; thence south along 3rd Ave SE to its intersection with 16th St SE; thence east along 16th St SE to its intersection with 11th Ave SE; thence southerly along 11th Ave SE to its intersection with Pinewood Rd SE; thence easterly along Pinewood Rd SE to its intersection with 36th Ave SE. Future annexation of territory now in Rochester Township south of Fox Valley

Drive SW, Marion Township east of 11th Ave SE/County Rd 1 and west of 36th Ave SE; and High Forest Township will be added to Ward 1.

Sec. 2-2-3. Second ward.

Ward 2 is comprised of all parts of the city encompassed by the following described line: beginning at the intersection of 12th Street SW and South Broadway; thence west along 12th Street SW to its intersection with Salem Road SW; thence west along Salem Road SW to its intersection with West Circle Drive SW; thence north along West Circle Drive SW to its intersection with the city limits line (north of the intersection of West Circle Drive SW and Historic Hills Drive SW); thence along the westernmost city limits line to its intersection with 19th Street NW; thence east along 19th Street NW to its intersection with West Circle Drive NW; thence south along West Circle Drive NW to its intersection with Trunk Highway 14; thence east along TH 14 to its intersection with TH 52; thence south along TH 52 to its intersection with 4th Street NW, extended; thence east along 4th Street NW to its intersection with 16th Avenue NW; thence northerly along 16th Avenue NW to its crossing of Cascade Creek; thence east along Cascade Creek to the Civic Center Drive NW crossing; thence east along Civic Center Drive NW to its intersection with 6th Avenue NW; thence south along 6th Avenue NW to West Center Street; thence south along 6th Avenue SW to its intersection with 6th Street SW; thence east along 6th Street SW to its intersection with South Broadway; thence south along South Broadway to the point of beginning. Future annexations of territory now in Cascade Township south of 19th Street NW will be added to Ward 2. that are located south of 19th St NW, north of a line described as: beginning at the intersection of West Circle Drive SW and Fox Valley Dr SW; thence easterly along Fox Valley Dr SW to the intersection of Salem Road SW; thence northeast along Salem Road SW until it becomes Trunk Highway 14 / 12th St SW; thence easterly along Trunk Highway 14 / 12th St SW to its intersection of Broadway Ave S., and that are located westerly of a line described as: beginning at the intersection of Trunk Highway 52 and 19th St NW; thence south along Trunk Highway 52 to its intersection of Civic Center Dr NW; thence easterly along Civic Center Dr NW to its intersection of 6th Ave NW; thence south along 6th Ave NW to its intersection of 2nd St SW; thence east along 2nd St SW to its intersection of Broadway Ave S.; thence south along Broadway Ave S. to its intersection of Trunk Highway 14 / 12th St SW and there terminating. Future annexations of territory now in Rochester Township north of Fox Valley Drive SW, and Cascade Township south of Civic Center Drive NW will be added to Ward 2.

Sec. 2-2-4. Third ward.

Ward 3 encompasses all parts of the city north and west of the following described line: beginning at the westernmost city limits boundary along 19th Street NW; thence east along 19th Street NW to its intersection with West Circle Drive NW; thence north along

West Circle Drive NW to its intersection with 41st Street NW; thence east along 41st Street NW to its intersection with 22nd Avenue NW; thence north along 22nd Avenue NW to its intersection with 42nd Street NW; thence east along 42nd Street NW to its intersection with 19th Avenue NW; thence north along 19th Avenue NW to its intersection with 43rd Street NW; thence east along 43rd Street NW to its intersection with 18th Avenue NW; thence north along 18th Avenue NW to the northernmost city limits (at Overland Drive NW). Future annexations of territory in Cascade Township west of 18th Avenue NW and north of 19th Street NW will be added to Ward 3. lying north of 19th St NW and to the west of the following described line: Beginning at the intersection of 19th ST NW and Valleyhigh Dr NW; thence northerly along Valleyhigh Dr NW to its intersection of 25th ST NW; thence easterly along 25th ST NW to its intersection of 29th Ave NW; thence northerly along 29th Ave NW and easterly along 26th St NW to the intersection of Trunk Highway 52; thence northerly along Trunk Highway 52 to its intersection of 55th ST NW; thence easterly along 55th St NW to its intersection of 18th Ave NW; thence north along 18th Ave NW to the limits of the City. 18th Ave NW represents the easterly extent of the described line. Future annexations of territory now in Kalmar Township, and Cascade Township north of Civic Center Drive NW and west of 18th Ave NW will be added to Ward 3.

Sec. 2-2-5. Fourth ward.

Ward 4 is comprised of all parts of the city encompassed by the following described line: beginning at the intersection of the east city limits with Marion Road SE; thence north along Marion Road SE to its intersection with the boundary between Legislative Districts 26A and 26B north of 24th Avenue SE; thence west along the boundary between Legislative Districts 26A and 26B to its intersection with Bear Creek; thence southwesterly (downstream) along Bear Creek to its confluence with Willow Creek; thence southwesterly (upstream) along Willow Creek to the 11th Avenue SE crossing; thence northerly along 11th Avenue SE to its intersection with 12th Street SE; thence west along 12th Street SE to its intersection with South Broadway; thence north along South Broadway to its intersection with 6th Street SW; thence west along 6th Street SW to its intersection with 6th Avenue SW; thence north along 6th Avenue SW to its intersection with West Center Street; thence north along 6th Avenue NW to its intersection with Civic Center Drive NW; thence easterly along Civic Center Drive NW to its intersection with North Broadway; thence east along Civic Center Drive NE to its intersection with West Silver Lake Drive NE; thence east along 2nd Street NE, extended, to the Zumbro River; thence north along the Zumbro River to its confluence with Silver Creek; thence easterly (upstream) along Silver Creek to the DM&E Railroad crossing; thence east along the DM&E Railroad to the east city limits. Future annexations of territory in Haverhill Township south of the DM&E Railroad and in Marion Township north of Marion Road SE will be added to Ward 4. that are located south of a line described as: beginning at the intersection of 6th Ave NW and Civic Center Dr NW; thence easterly along Civic Center Dr NW / Civic Center Dr NE to its terminus; thence continuing east across West Silver Lake Dr NE and continuing east along 2nd St NE to its terminus and continuing east to the center of Zumbro River; thence northerly along the Zumbro River to its confluence with

Silver Creek; thence easterly (upstream) along Silver Creek to the DM&E Railroad crossing which is also the West line of Section 31, Township 107 North, Range 13 West; thence south along said section line to its intersection of College View Rd E; thence east along College View Rd E to its intersection of 30th Ave SE; thence south along 30th Ave SE to its intersection of Trunk Highway 14; thence east along Trunk Highway 14 to a point on the East line of the West ½ of Section 4, Township 106 North, Range 13 West; and that are located east of the following described line: Beginning at the intersection of Civic Center Dr NW and 6th Ave NW; thence south along 6th Ave NW to its intersection of 2nd St SW; thence east along 2nd St SW/2nd S SE to its intersection of Broadway Ave S; thence south along Broadway Ave S. to its intersection of 12th St SE / Trunk Highway 14; thence east along 12th St SE / Trunk Highway 14 to its intersection with 3rd Ave SE; thence south along 3rd Ave SE to its intersection of 16th St SE; thence east along 16th St SE to its intersection of 11th Ave SE; thence south along 11th Ave SE to its intersection of Pinewood Rd SE; thence east along Pinewood Rd SE to its intersection of 36th Ave SE; thence south along 36th Ave SE to its intersection of 30th St SE; thence east along 30th St SE to the Northeast corner of Section 20, Township 106 North, Range 13 West; thence south along the East section line of said Section 20 to the limits of the City of Rochester. Future annexations of territory now in Marion Township south of Highway 14 and east of 36th Ave SE will be added to Ward 4.

Sec. 2-2-6. Fifth ward.

Ward 5 is comprised of all parts of the city encompassed by the following described line: ~~Beginning at the east city limits line along the DM&E Railroad; thence west along the DM&E Railroad to its crossing of Silver Creek; thence westerly (downstream) along Silver Creek to its confluence with the Zumbro River; thence south (upstream) along the Zumbro River to 2nd Street NE, extended; thence west along 2nd Street NE to its intersection with West Silver Lake Drive NE; thence westerly along Civic Center Drive NE to its intersection with north Broadway; thence westerly along Civic Center Drive NW to its crossing of Cascade Creek; thence westerly (upstream) along Cascade Creek to the 16th Avenue NW crossing; thence southwestly along 16th Avenue NW to its intersection with 4th Street NW; thence west along 4th Street NW, extended, to its intersection with Trunk Highway 52; thence north along TH 52 to its intersection with 19th Street NW; thence easterly along the power line extending from 19th Street NW, extended, to the intersection of 19th Street NW with Viking Drive NW; thence northeasterly along Viking Drive NW to its intersection with Elton Hills Drive NW; thence southeasterly along Elton Hills Drive NW to the Zumbro River crossing; thence northerly along the Zumbro River to the northernmost city limits. Future annexations of territory now in Haverhill Township north of the DM&E Railroad and now in Cascade Township east of the Zumbro River will be added to Ward 5.—~~ that are located east of a line described as: beginning at the intersection of 44th St NE and East River Road NE; thence south along East River Rd NE to its intersection of 37th St NE; thence west along 37th St NE to its intersection with the Zumbro River; thence southerly (upstream) along the Zumbro River to its intersection of

Elton Hills Dr NW; thence west along Elton Hills Dr NW to its intersection of Viking Dr NW; thence southerly along Viking Dr NW to its intersection of 19th St NW which is also the North line of the South 1/2 , Section 20, Township 107 North, Range 14 West; thence west along said half section line to the Northwest corner of the South ½ of said Section 20; thence continuing west along the North line of the South 1/2 of Section 27, Township 107 North, Range 14 West to its intersection of Trunk Highway 52; thence south along Trunk Highway 52 to its intersection of Civic Center Dr NW, and that is north of a line described as: beginning at the intersection Trunk Highway 52 and Civic Center Dr NW; thence easterly along Civic Center Dr NW / Civic Center Dr NE to its terminus; thence continuing east across West Silver Lake Dr NE and continuing east along 2nd St NE to its terminus and continuing east to the center of Zumbro River; thence northerly along the Zumbro River to its confluence with Silver Creek; thence easterly (upstream) along Silver Creek to the DM&E Railroad crossing which is also the West line of Section 31, Township 107 North, Range 13 West; thence south along said section line to its intersection of College View Rd E; thence east along College View Rd E to its intersection of 30th Ave SE; thence south along 30th Ave SE to its intersection of Trunk Highway 14; thence east along Trunk Highway 14 to the limits of the City of Rochester. Future annexation of territory now in Marion Township north of Highway 14 SE, and Haverhill Township, and Cascade Township west of E River Road NE, continuing north to Hallmark Terrace NE, through Buckridge Park to the Zumbro River to the west will be added to Ward 5.

Sec. 2-2-7. Sixth ward.

~~Ward 6 is comprised of all parts of the city encompassed by the following described line: beginning at the northernmost city limits line along the Zumbro River; thence southerly along the Zumbro River to the Elton Hills Drive NW crossing; thence northwesterly along Elton Hills Drive NW to its intersection with Viking Drive NW; thence southwesterly along Viking Drive NW to its intersection with 19th Street NW; thence westerly along 19th Street NW, extended, to its intersection with Trunk Highway 52; thence south along TH 52 to its intersection with Trunk Highway 14; thence westerly along TH 14 to its intersection with West Circle Drive NW; thence northerly along West Circle Drive NW to its intersection with 41st Street NW; thence east along 41st Street NW to its intersection with 22nd Avenue NW; thence north along 22nd Avenue NW to its intersection with 43rd Street NW; thence east along 43rd Street NW to its intersection with 18th Avenue NW; thence north along 18th Avenue NW to the northernmost city limits. Future annexations of territory now in Cascade Township west of the Zumbro River and east of 18th Avenue NW will be added to Ward 6.~~ beginning at the intersection of 18th Ave NW and 55th St NW; thence west along 55th ST NW to its intersection with Trunk Highway 52; thence south along Trunk Highway 52 to its intersection with 26th St NW; thence west along 26th St NW to the curve where it becomes 29th Ave NW; thence south along 29th Ave NW to its intersection with 25th St NW; thence west along 25th St NW to its intersection with Valleyhigh Dr NW; thence south along Valleyhigh Dr NW to its intersection of 19th St NW; thence east along 19th ST NW to its intersection of Trunk Highway 52; thence east along the North line of the South 1/2 of Section 27, Township


107 North, Range 14 West to the Northwest corner of the South ½ of said Section 20; thence continuing east along said half section line to the intersection of 19th St NW and Viking Dr NW; thence north along Viking Dr NW to the intersection of Elton Hills Dr NW; thence southerly along Elton Hills Dr NW to its intersection with the Zumbro River; thence northerly (downstream) along the Zumbro River to its intersection of 37th St NE; thence east along 37th St NE to its intersection of East River Rd NE; thence north along East River Rd NE to its intersection of 48th St NE; thence west along 48th St NE / 48th St NW to its intersection of 18th Ave NW and there terminating. Future annexations now in Cascade Township east of 18th Ave NW and west of E River Road NE continuing north to Hallmark Terrace NE, through Buckridge Park to the Zumbro River will be added to Ward 6.

Section 2. This ordinance shall become effective as of the date of its publication.

RESOLUTION

Establishing Precincts within the New 2022 Ward Boundaries Post-Redistricting.

WHEREAS, on March 24, 2022, the Common Council of the City of Rochester, Minnesota, adopted new Ward boundaries for the City of Rochester after the completion of 2020 redistricting efforts; and

WHEREAS, the Council must now approve the precincts within the new Wards.

NOW, THEREFORE, BE IT RESOLVED, by the Common Council of the City of Rochester, Minnesota, that the follow precinct boundary descriptions are adopted:

Ward 1:

Precinct 1: The First Precinct of Ward 1 shall be comprised of all that part of Ward 1 which lies north of Mayowood Road SW, west of Highway 52 SW, and south of a line described as beginning at the intersection of 12th ST SW with Trunk Highway 52, thence westerly along the North Frontage Rd Salem SW and Salem Rd SW, and West Circle Dr SW to the northerly boundary of Ward 1 boundary.

Precinct 2: The Second Precinct of Ward 1 shall be comprised of all that part of Ward 1 which lies south of Fox Valley Dr SW, north of N Frontage Rd Salem SW and Salem Rd SW, and east of W Circle Dr.

Precinct 3: The Third Precinct of Ward 1 shall be comprised of all that part of Ward 1 which lies south of 12th SW, west of Broadway Ave S, north of 16th St SW, and east of Trunk Highway 52 SW.

Precinct 4: The Fourth Precinct of Ward 1 shall be comprised of all that part of Ward 1 which lies south of 12th St SE, west of 11th Ave SE, north of 20th St SE, and east of Broadway Ave S.

Precinct 5: The Fifth Precinct of Ward 1 shall be comprised of all that part of Ward 1 which lies south of 16th St SW, west of Broadway Ave S, north of 20th St SW, and east of Highway 52 SW.

Precinct 6: The Sixth Precinct of Ward 1 shall be comprised of all that part of Ward 1 which lies north of Hart Drive SW, west of 18th Avenue SW, and south of Mayowood Road SW.

Precinct 7: The Seventh Precinct of Ward 1 shall be comprised of all that part of Ward 1 which lies within a boundary described as beginning at the intersection of Mayowood Rd SW with Trunk Highway 52; thence southerly along Trunk Highway 52 to its intersection of Highway 63 S; thence south along Trunk Highway 63 S to its intersection of 40th St SW; thence west along 40th St SW to its intersection of Willow Ridge Dr SW; thence north along Willow Ridge Dr SW to its intersection of 36th ST SW; thence west along 36th St SW to its intersection of 18th Ave SW; thence north along 18th Ave SW to its intersection of Mayowood Rd SW; thence east along Mayowood Rd SW to the point of beginning.

Precinct 8: The Eighth Precinct of Ward 1 shall be comprised of all that part of Ward 1 which lies within a boundary described as beginning at the intersection of Mayowood Rd SW with Trunk Highway 52; thence northerly along Mayowood Rd SW to its intersection of 20th St SW; thence southerly and easterly along 20th St SW to its intersection of Broadway Ave S.; thence south

along Broadway Ave S to its intersection of Trunk Highway 52; thence northwesterly along Trunk Highway 52 to the point of beginning.

Precinct 9: The Ninth Precinct of Ward 1 shall be comprised of all that part of Ward 1 which lies south of 20th St SE, west of 11th Ave SE and Bear Creek, north of 25th St SE (as extended east from Broadway Ave S to Bear Creek), and east of Broadway Ave S.

Precinct 10: The Tenth Precinct of Ward 1 shall be comprised of all that part of Ward 1 which lies east of Broadway Ave S. / Trunk Highway 63 S., west of Simpson Rd SE, and south of a line described as beginning at the intersection of 25th ST SE and Broadway Ave S.; thence east along 25th St SE to its terminus and thence continuing east to the intersection of Willow Creek; thence following Willow Creek northeasterly to the boundary of Ward 1 and there terminating.

Precinct 11: The Eleventh Precinct of Ward 1 shall be comprised of all that part of Ward 1 which lies south of Pinewood Rd SE, east of 11th Ave SE, north of Trunk Highway 52, and west of 36th Ave SE.

Precinct 12: The Twelfth Precinct of Ward 1 shall be comprised of all that part of Ward 1 which lies north of 40th St SE, west of Willow Ridge Dr SW, and lying south of a line described as beginning at the intersection of 36th St SW and Willow Ridge Dr SW; thence west along 36th St SW to its intersection of 18th Ave SW; thence continuing west on Hart Dr SW to the Ward 1 boundary and there terminating.

Precinct 13: The Thirteenth Precinct of Ward 1 shall be comprised of all that part of Ward 1 which lies north of 60th St SW, and west of Highway 63 S, and south of a line described as beginning at the intersection of Bamber Valley Dr SW and 48th St SW; thence east along 48th St SW to its intersection of 11th Ave SW; thence north along 11th Ave SW to its intersection of 40th St SW; thence east along 40th ST SW to its intersection of Trunk Highway 63 S and there terminating.

Precinct 14: The Fourteenth Precinct of Ward 1 shall be comprised of all that part of Ward 1 which lies south of 60th St SW, and west of Highway 63 S.

Ward 2:

Precinct 1: The First Precinct of Ward 2 shall be comprised of all that part of Ward 2 which lies north of 7th St SW, west of W Circle Dr NW, and south of 19th St NW, extending to the boundary of Ward 2 and western City limit.

Precinct 2: The Second Precinct of Ward 2 shall be comprised of all that part of Ward 2 which lies north of Highway 14 NW, west of Trunk Highway 52, south of 19th St NW, and east of W Circle Dr NW.

Precinct 3: The Third Precinct of Ward 2 shall be comprised of all that part of Ward 2 which lies south of 7th St NW, west of Manor Park Dr NW, and north of 3rd St NW extending to the Ward 2 boundary and western City limit.

Precinct 4: The Fourth Precinct of Ward 2 shall be comprised of all that part of Ward 2 which lies south of 7th St NW, west of W Circle Dr NW, north of 3rd St NW, and northeast of Manor Park Dr NW.

Precinct 5: The Fifth Precinct of Ward 2 shall be comprised of all that part of Ward 2 which lies south of Trunk Highway 14 NW, east of W Circle Dr NW, west of Trunk Highway 52, and north of

a line described as beginning at the intersection of West Circle Dr SW and 2nd St SW; thence east along 2nd St SW to its intersection of Avalon Ct SW and the east line of the Avalon Cove subdivision; thence north along the east line of Avalon Cove to the northeast corner of said subdivision; thence continuing north to Cascade Creek; thence easterly along Cascade Creek to its intersection of Trunk Highway 52 and there terminating.

Precinct 6: The Sixth Precinct of Ward 2 shall be comprised of all that part of Ward 2 which lies north of 2nd ST SW, west of Trunk Highway 52, and east and south of a line described as beginning at the intersection of 2nd St SW and Avalon Ct SW at the east line of the Avalon Cove subdivision; thence north along the east line of Avalon Cove to the northeast corner of said subdivision; thence continuing north to Cascade Creek; thence easterly along Cascade Creek to its intersection of Trunk Highway 52 and there terminating.

Precinct 7: The Seventh Precinct of Ward 2 shall be comprised of all that part of Ward 2 which lies south of City Center Dr NW, west of 11th Ave SW, north of 2nd St SW, and east of Highway 52.

Precinct 8: The Eighth Precinct of Ward 2 shall be comprised of all that part of Ward 2 which lies south of Civic Center Dr NW, west of 6th Ave NW/6th St SW, north of 2nd ST SW, and east of 11th Ave NW/11th Ave SW.

Precinct 9: The Ninth Precinct of Ward 2 shall be comprised of all that part of Ward 2 which lies south of 3rd St NW, west of W Circle Dr NW extending to the westerly boundary of Ward 2, and north of a line described as beginning at the intersection of West Circle Dr SW and Country Club Rd SW; thence west along Country Club Rd SW to the westerly extent of Ward 2.

Precinct 10: The Tenth Precinct of Ward 2 shall be comprised of all that part of Ward 2 which lies south of Country Club Rd W and 2nd St SW, north of Fox Valley Dr SW, and west of a line described as beginning at the intersection of 23rd Ave SW with 2nd St SW; thence south along 23rd Ave SW its intersection of Fox Valley PI SW; thence south along Fox Valley PI SW to its intersection of Fox Valley Dr SW and there terminating.

Precinct 11: The Eleventh Precinct of Ward 2 shall be comprised of all that part of Ward 2 which lies south of 2nd St SW, west of Trunk Highway 52, east of a line described as beginning at the intersection of 23rd Ave SW and 2nd ST SW; thence south along 23rd Ave SW to its intersection of Fox Valley PI SW; thence south along Fox Valley PI SW to its intersection of Fox Valley Dr SW and there terminating, and lying north of a line described as beginning at the intersection of Fox Valley PI SW and Fox Valley Dr SW; thence easterly along Fox Valley Dr SW to its intersection of Salem Rd SW; thence northerly along Salem Rd SW to its intersection of Trunk Highway 52 and there terminating.

Precinct 2: The Second Precinct of Ward 6 shall be comprised of all that part of Ward 6 which lies east of 18th Ave NW, west of the Zumbro River, north of Essex Pkwy NW, and south of 55th ST NW / 48th St NW.

Precinct 3: The Third Precinct of Ward 6 shall be comprised of all that part of Ward 6 which lies west of 18th Ave NW, east of 22nd Ave NW, south of 50th St NW, and north of 42nd ST NW.

Precinct 4: The Fourth Precinct of Ward 6 shall be comprised of all that part of Ward 6 which lies east of 18th Ave NW, west of E. River Rd NW, south of a line described as beginning at the intersection of 18th Ave NW and Essex Pkwy NW; thence east along Essex Pkwy NW to its intersection of W. River Rd NW; thence north along W. River Rd NW to the northerly extent of Ward 6 and there terminating, and north of a line described as beginning at the intersection of 45th St NW and 18th Ave NW; thence east along 45th St NW to its intersection of 14th Ave NW; thence north along 14th Ave NW to its intersection of 46th St NW; thence east along 46th St NW to its intersection of 13th Ave NW; thence south along 13th Ave NW to its intersection of 41st St NW; thence east along 41st ST NW to its intersection of W. River Pkwy NW; thence south along W. River Pkwy NW to its intersection of 37th St NW; thence east along 37th St NW to its intersection of E. River Rd NW and there terminating.

Precinct 5: The Fifth Precinct of Ward 6 shall be comprised of all that part of Ward 6 which lies north of 37th St NW, east of Highway 52 NW, west of 18th Ave NW, and south of a line described as beginning at the intersection of Hwy 52 NW and 41st St NW; thence east along 41st St NW to its intersection of the E. Frontage Rd Hwy 52 NW; thence north along the E. Frontage Rd to its intersection of 22nd Ave NW; thence north along 22nd Ave NW to its intersection of 42nd St NW; thence east along 42nd St NW curving north to its intersection of 43rd St NW; thence east along 43rd St NW to its intersection of 18th Ave NW and there terminating.

Precinct 6: The Sixth Precinct of Ward 6 shall be comprised of all that part of Ward 6 which lies north of 37th St NW, east of 18th Ave NW, west of W. River Parkway NW, and south of a line described as beginning at the intersection of 45th St NW and 18th Ave NW; thence east along 45th St NW to its intersection of 14th Ave NW; thence north along 14th Ave NW to its intersection of 46th St NW; thence east along 46th St NW to its intersection of 13th Ave NW; thence south along 13th Ave NW to its intersection of 41st St NW; thence east along 41st St NW to its intersection of W. River Pkwy NW and there terminating.

Precinct 7: The Seventh Precinct of Ward 6 shall be comprised of all that part of Ward 6 which lies south of 37th St NW, east of Trunk Hwy 52, west of a line described as beginning at the intersection of 37th St NW and W. River Pkwy NW; thence south along W. River Pkwy NW to its intersection of 9th Ave NW; thence south along 9th Ave NW to its intersection of 33rd St NW and there terminating, and North of a line described as beginning at the intersection of Trunk Hwy 52 and 18th Ave NW; thence north along 18th Ave NW to its intersection of 31st St NW; thence east along 31st St NW to its intersection of 15th Ave NW; thence north along 15th Ave NW to its intersection of 33rd St NW; thence east along 33rd St NW to its intersection of 9th Ave NW and there terminating.

Precinct 8: The Eighth Precinct of Ward 6 shall be comprised of all that part of Ward 6 which lies south of 37th St NW, west of the Zumbro River, east of a line described as beginning at the intersection of W. River Pkwy NW and 37th St NW; thence south along W. River Pkwy NW to its intersection of 9th Ave NW; thence south along 9th Ave NW to its intersection of Elton Hills Dr NW and there terminating, and north of a line described as beginning at the intersection of 9th Ave NW and Elton Hills Dr NW; thence east along Elton Hills Dr NW to its intersection of Zumbro Dr NW; thence northeasterly along Zumbro Dr NW to its intersection of W. River Pkwy NW; thence south along W. River Pkwy NW to its intersection of Elton Hills Dr NW; thence east along Elton Hills Dr NW to the Zumbro River and there terminating.

Precinct 9: The Ninth Precinct of Ward 6 shall be comprised of all that part of Ward 6 which lies east of 18th Ave NW, west of 9th Ave NW, south of a line described as beginning at the intersection of 18th Ave NW and 31st St NW; thence east along 31st St NW to its intersection of 15th Ave NE; thence north along 15th Ave NW to its intersection of 33rd St NW; thence east along 33rd St NW to its intersection of 9th Ave NW and there terminating, and North of a line described as beginning at the intersection of Cascade St NW and 18th Ave NW; thence east along Cascade St NW to its intersection of 12th Ave NW; thence south along 12th Ave NW to its intersection of Elton Hills Dr NW; thence east along Elton Hills Dr NW to its intersection of 9th Ave NW and there terminating.

Precinct 10: The Tenth Precinct of Ward 6 shall be comprised of all that part of Ward 6 which lies west of a line described as beginning at the intersection of 26th St NW and 25th Ave NW; thence south along 25th Ave NW to its intersection of 22nd St NW; thence east along 22nd St NW to its intersection of 23rd Ave NW; thence south along 23rd Ave NW to its intersection of 21st St NW; thence southeasterly along 21st St NW to its intersection of 20th St NW; thence east along

20th St NW to its intersection of 20th Ave NW; thence south along 20th Ave NW to its intersection of 19th St NW and there terminating.

Precinct 11: The Eleventh Precinct of Ward 6 shall be comprised of all that part of Ward 6 which lies west of Trunk Highway 52, and east of a line described as beginning at the intersection of 26th St NW and 25th Ave NW; thence south along 25th Ave NW to its intersection of 22nd St NW; thence east along 22nd St NW to its intersection of 23rd Ave NW; thence south along 23rd Ave NW to its intersection of 21st St NW; thence southeasterly along 21st St NW to its intersection of 20th St NW; thence east along 20th St NW to its intersection of 20th Ave NW; thence south along 20th Ave NW to its intersection of 19th St NW and there terminating.


Precinct 12: The Twelfth Precinct of Ward 6 shall be comprised of all that part of Ward 6 which lies east of a line described as beginning at the intersection of 18th Ave NW and Cascade St NW; thence south along 18th Ave NW to its intersection of the E Frontage Rd Hwy 52 NW; thence south along the E. Frontage Rd to 19th St NW and there terminating, and south of a line described as beginning at the intersection of Cascade St NW and 18th Ave NW; thence east along Cascade St NW to its intersection of 12th Ave NW; thence south along 12th Ave NW to its intersection of Elton Hills Dr NW; thence east along Elton Hills Dr NW to its intersection of 4th Ave NW / Valkyrie Dr NW and there terminating, and west of Valkyrie Dr NW.

Precinct 13: The Thirteenth Precinct of Ward 6 shall be comprised of all that part of Ward 6 which lies within the following described boundary: Beginning at the intersection of Valkyrie Dr NW and 19th St NW, thence east along 19th St NW to its intersection of Viking Dr NW; thence northeast along Viking Dr NW to its intersection of Elton Hills Dr NW; thence easterly along Elton Hills Dr NW to its intersection of W. River Pkwy NW; thence northerly along W. River Pkwy NW to its intersection of Zumbro Dr NW; thence westerly along Zumbro Dr NW to its intersection of Elton Hills Dr NW; thence southeasterly along Elton Hills Dr NW to its intersection of Valkyrie Dr NW; thence southwesterly along Valkyrie Dr NW to its intersection of 19th St NW and the point of beginning.
