

RESOLUTION NO. 26-22

A RESOLUTION ESTABLISHING PRECINCTS AND POLLING PLACES

WHEREAS, the legislature of the State of Minnesota has been redistricted; and

WHEREAS, Minnesota Statute section 204B.14, subd 3(d) requires that precinct boundaries must be established with 60 days of when the legislature has been redistricted or at least 19 weeks before the state primary election, whichever comes first; and

WHEREAS, the City of Owatonna has five wards and the boundaries of the wards established by passage of Ordinance 1630;

NOW, THEREFORE BE IT RESOLVED THAT THE City Council of the City of Owatonna, County of Steele, State of Minnesota hereby establishes the boundaries of the voting precincts as follows:

**FIRST WARD - FIRST PRECINCT**

That portion of the City lying east of the following boundary: From the center of the intersection of Rose Street and the east City Limits line west along the center line of Rose Street to the center of its intersection with Willow Avenue, thence south along the center line of Willow Avenue to the center of its intersection with Vine Street, thence westerly along the center line of Vine Street to the center of its intersection with Grove Avenue, thence south along the center line of Grove Avenue to the center of its intersection with Broadway Street, thence west along the center line of Broadway Street to the center of its intersection with West Park Square, thence south along the center line of West Park Square to the center of its intersection with Main Street, thence east along the center line of Main Street to the center of its intersection with South Cedar Avenue, thence south along the center line of South Cedar Avenue to the center of its intersection with Harriet Avenue, thence north along the center line of Harriet Avenue to the center of its intersection with School Street, thence east along the center line of School Street to the center of its intersection with Harriet Avenue, thence south along the center line of Harriet Avenue to the center of its intersection with South Street, thence east along the center line of South Street to the center of its intersection with Truman Avenue, thence north along the center line of Truman Avenue to the center of its intersection with Prospect Street, thence east along the center line of Prospect Street to the center of its intersection with Minnesota Avenue, thence north along the center line of Minnesota Avenue to the center of its intersection with School Street, thence east along the center line of School Street to the center of its intersection with County Road 80, thence southeasterly along the center line of County Road 80 to the east City Limits line.

**FIRST WARD - SECOND PRECINCT**

That portion of the City lying east of the following boundary: From the center of the intersection of 18th Street SE and the east City Limits line west along the center line of 18th Street SE to the center of its intersection with Austin Road, thence northerly along the center line of Austin Road to the center of its intersection with Lincoln Avenue, thence northerly along the center line of Lincoln Avenue to the center of its intersection with South Street, thence east along the center line of South Street to the center of its intersection with Truman Avenue, thence north along the center line of Truman Avenue to the center of its intersection with Prospect Street, thence east along the center line of Prospect Street to the center of its

intersection with Minnesota Avenue, thence north along the center line of Minnesota Avenue to the center of its intersection with School Street, thence east along the center line of School Street to the center of its intersection with County Road 80, thence southeasterly along the center line of County Road 80 to the east City Limits line.

**SECOND WARD - FIRST PRECINCT**

That portion of the City lying within the following boundary: From the center of the intersection of Mineral Springs Road and 10<sup>th</sup> Avenue NE southwesterly along the center line of Mineral Springs Road to the center of its intersection with Bigelow Avenue, thence north along the center line of Bigelow Avenue to the center of its intersection with 14<sup>th</sup> Street NE, thence west along the center line of 14<sup>th</sup> Street NE to the center of its intersection with North Elm Avenue, thence south along the center line of North Elm Avenue to the center of its intersection with 11<sup>th</sup> Street NE, thence west along the center line of 11<sup>th</sup> Street NE to the center of its intersection with North Cedar Avenue, thence south along the center line of North Cedar Avenue to the center of its intersection with Broadway Street, thence east along the center line of Broadway Street to the center of its intersection with Grove Street, thence north along the center line of Grove Street to the center of its intersection with Vine Street, thence easterly along the center line of Vine Street to the center of its intersection with Willow Avenue, thence north along the center line of Willow Avenue to the center of its intersection with Rose Street, thence west along the center line of Rose Street to the center of its intersection with Larch Avenue, thence northerly along the center line of Larch Avenue to the center of its intersection with Cherry Street, thence northeasterly along the center line of Cherry Street to the center of its intersection with 11<sup>th</sup> Avenue NE, thence northwesterly along the center line of 11<sup>th</sup> Avenue NE to the center of its intersection with Ridge Road, thence west along the center line of Ridge Road to the center of its intersection with 10<sup>th</sup> Avenue NE, thence north along the center line of 10<sup>th</sup> Avenue NE to the center of its intersection with Mineral Springs Road, the point of beginning.

**SECOND WARD - Second Precinct**

That portion of the City lying east of the following boundary: From the center of the intersection of 24<sup>th</sup> Avenue NE and the north City Limits line south along the center line of 24<sup>th</sup> Avenue NE to its intersection with 26<sup>th</sup> Street NE, thence southerly along the center line of Kenyon Road to the center of its intersection with Mineral Springs Road, thence southwesterly along the center line of Mineral Springs Road to the center of its intersection with 10<sup>th</sup> Avenue NE, thence south along the center line of 10<sup>th</sup> Avenue NE to the center of its intersection with Ridge Road, thence east along the center line of Ridge Road to the center of its intersection with 11<sup>th</sup> Avenue NE, thence south along the center line of 11<sup>th</sup> Avenue NE to the center of its intersection with Cherry Street, thence southwesterly along the center line of Cherry Street to the center of its intersection with Larch Avenue, thence south along the center line of Larch Avenue to the center line of its intersection with Rose Street, thence east along the center line of Rose Street to the east City Limits line.

**THIRD WARD - FIRST PRECINCT**

That portion of the City lying north of the following boundary: From the center of the intersection of Interstate 35 and the north City Limits line southerly along the center line of Interstate 35 to the center of its intersection with West Bridge Street, thence east along the center line of West Bridge Street to the center of its intersection with Florence Avenue, thence north along the centerline of Florence Avenue to the center of its intersection with

Glendale Street, thence east along the center line of Glendale Street to the center of its intersection with State Avenue, thence south along the center line of State Avenue to the center of its intersection with Flora Street, thence east along the center line of Flora Street to the center of its intersection with Flowervale Street, thence east along the center line of Flowervale Street to the center of its intersection with Riverside Avenue, thence south along the center line of Riverside Avenue to the center of its intersection with West Bridge Street, thence east along the center line of West Bridge Street to the center of its intersection with West Park Square, thence north along the center line of West Park Square to the center of its intersection with Broadway Street, thence east along the center line of Broadway Street to the center of its intersection with North Cedar Avenue, thence north along the center line of North Cedar Avenue to its intersection with the north City Limits line.

**THIRD WARD - Second Precinct** - That portion of the City lying west of the following boundary: From the center of the intersection of Interstate 35 and the north City Limits line southerly along the center line of Interstate 35 to the center of its intersection with West Bridge Street, thence east along the center line of West Bridge Street to the center of its intersection with Florence Avenue, thence north along the centerline of Florence Avenue to the center of its intersection with Glendale Street, thence east along the center line of Glendale Street to the center of its intersection with State Avenue, thence south along the center line of State Avenue to the center of its intersection with Flora Street, thence east along the center line of Flora Street to the center of its intersection with Flowervale Street, thence east along the center line of Flowervale Street to the center of its intersection with Riverside Avenue, thence south along the center line of Riverside Avenue to the center of its intersection with West Bridge Street, thence east along the center line of West Bridge Street to the center of its intersection with West Park Square, thence south along the center line of West Park Square to the center of its intersection with Main Street, thence east along the center line of Main Street to the center of its intersection with South Cedar Avenue, thence south along the center line of South Cedar Avenue to the center of its intersection with School Street, thence west along the center line of School Street to its intersection with Union Pacific Railroad, thence south along the center line of Union Pacific Railroad to its intersection with the south City Limits line.

**FOURTH WARD - FIRST PRECINCT**

That portion of the City lying within the following boundary: From the center of the intersection of Harriet Avenue and School Street south along the center line of Harriet Avenue to the center of its intersection with South Street, thence east along the center line of South Street to the center of its intersection with Lincoln Avenue, thence southerly along the center line of Lincoln Avenue to the center of its intersection with 12<sup>th</sup> Street SE, thence west along the center line of 12<sup>th</sup> Street SE to the center of its intersection with Kast Avenue, thence south along the center line of Kast Avenue to the center of its intersection with Park Street, thence west along the center line of Park Street to the center of its intersection with Austin Road, thence northwesterly along the center line of Austin Road to the center of its intersection with South Grove Avenue, thence south along the center line of South Grove Avenue to the center of its intersection with Hobart Street, thence west along the center line of Hobart Street to the center of its intersection with South Elm Avenue, thence south along the center line of South Elm Avenue to the center of its intersection with Hobart Street, thence west along the center line of Hobart Street to the center of its intersection with South Cedar Avenue, thence north along the center line of South Cedar Avenue to the center of its

intersection with Holly Street, thence west along the center line of Holly Street to the center of its intersection with Linn Avenue, thence south along the center line of Linn Avenue to the center of its intersection with 16<sup>th</sup> Street SW, thence west along the center line of 16<sup>th</sup> Street SW to the center of its intersection with Mosher Avenue, thence north along the center line of Mosher Avenue to the center of its intersection with Barney Street, thence west along the center line of Barney Street to the center of its intersection with Union Pacific Railroad, thence northerly along the center line of Union Pacific Railroad to the center of its intersection with School Street, thence east along the center line of School Street to the center of its intersection with Harriet Avenue, the point of beginning.

#### **FOURTH WARD - Second Precinct**

That portion of the City lying south of the following boundary: From the center of the intersection of 18th Street SE and the east City Limits line west along the center line of 18<sup>th</sup> Street SE to the center of its intersection with Austin Road, thence northerly along the center line of Austin Road to the center of its intersection with Lincoln Avenue, thence northerly along the center line of Lincoln Avenue to the center of its intersection with 12th Street SE, thence west along the center line of 12<sup>th</sup> Street SE to the center of its intersection with Kast Avenue, thence south along the center line of Kast Avenue to the center of its intersection with Park Street, thence west along the center line of Park Street to the center of its intersection with Austin Road, thence northwesterly along the center line of Austin Road to the center of its intersection with South Grove Avenue, thence south along the center line of South Grove Avenue to the center of its intersection with Hobart Street, thence west along the center line of Hobart Street to the center of its intersection with South Elm Avenue, thence south along the center line of South Elm Avenue to the center of its intersection with Hobart Street, thence west along the center line of Hobart Street to the center of its intersection with South Cedar Avenue, thence north along the center line of South Cedar Avenue to the center of its intersection with Holly Street, thence west along the center line of Holly Street to the center of its intersection with Linn Avenue, thence south along the center line of Linn Avenue to the center of its intersection with 16<sup>th</sup> Street SW, thence west along the center line of 16<sup>th</sup> Street SW to the center of its intersection with Mosher Avenue, thence north along the center line of Mosher Avenue to the center of its intersection with Barney Street, thence west along the center line of Barney Street to the center of its intersection with Union Pacific Railroad, thence southerly along the center line of Union Pacific Railroad to the south City Limits line.

#### **FIFTH WARD - FIRST PRECINCT**

That portion of the City lying north of the following boundary: From the center of the intersection of North Cedar Avenue and the north City Limits line southerly along the center line of North Cedar Avenue to the center of its intersection with 11<sup>th</sup> Street NE, thence easterly along the center line of 11<sup>th</sup> Street NE to the center of its intersection with North Elm Avenue, thence north along the center line of North Elm Avenue to the center of its intersection with 16<sup>th</sup> Street NE, thence east along the center line of 16<sup>th</sup> Street NE to the center of its intersection with 3<sup>rd</sup> Avenue NE, thence north along the center line of 3<sup>rd</sup> Avenue NE to the center of its intersection with 20<sup>th</sup> Street NE, thence east along the center line of 20<sup>th</sup> Street NE to the center of its intersection with 6<sup>th</sup> Avenue NE, thence north along the center line of 6<sup>th</sup> Avenue NE to the center of its intersection with 22<sup>nd</sup> Street NE, thence east along the center line of 22<sup>nd</sup> Street NE to the center of its intersection with Hemlock Avenue NE, thence north along the center line of Hemlock Avenue to the north City Limits line.

**FIFTH WARD - Second Precinct**

That portion of the City lying north of the following boundary: From the center of the intersection of 24<sup>th</sup> Avenue NE and the north City Limits line south along the center line of 24<sup>th</sup> Avenue NE to its intersection with 26<sup>th</sup> Street NE, thence southerly along the center line of Kenyon Road to the center of its intersection with Mineral Springs Road, thence southwesterly along the center line of Mineral Springs Road to the center of its intersection with Bigelow Avenue, thence north along the center line of Bigelow Avenue to the center of its intersection with 14th Street NE, thence west along the center line of 14th Street NE to the center of its intersection with North Elm Avenue, thence north along the intersection of North Elm Avenue to the center of its intersection with 16<sup>th</sup> Street NE, thence east along the center line of 16<sup>th</sup> Street NE to the center of its intersection with 3<sup>rd</sup> Avenue NE, thence north along the center line of 3<sup>rd</sup> Avenue NE to the center of its intersection with 20<sup>th</sup> Street NE, thence east along the center line of 20<sup>th</sup> Street NE to the center of its intersection with 6<sup>th</sup> Avenue NE, thence north along the center line of 6<sup>th</sup> Avenue NE to the center of its intersection with 22<sup>nd</sup> Street NE, thence east along the center line of 22<sup>nd</sup> Street NE to the center of its intersection with Hemlock Avenue NE, thence north along the center line of Hemlock Avenue to the north City Limits line; and,

the polling places for each of the precincts shall be located at the following locations:


- Ward 1 / Precinct 1: Trinity Lutheran Church, 609 Lincoln Avenue

- Ward 3 / Precinct 2: Emmanuel Lutheran Church, 750 Jeffrey Street
- Ward 4 / Precinct 1: Sacred Heart Parish Center, 739 South Oak
- Ward 4 / Precinct 2: Steele County History Center, 1790 Austin Road
- Ward 5 / Precinct 1: Grace Baptist Church, 265 NE 26th Street
- Ward 5 / Precinct 2: Our Savior’s Lutheran Church, 1909 St. Paul Road





# 1ST WARD 1ST PRECINCT





# 1ST WARD 2ND PRECEINCT




# 2ND WARD 1ST PRECINCT




# 2ND WARD 2ND PRECINCT


# 3RD WARD 1ST PRECINCT




# 4TH WARD 1ST PRECINCT




# 4TH WARD 2ND PRECINCT




# 5TH WARD 2ND PRECINCT
