Whereas, it appears by the attached supporting documents, which I certify to be authentic and duly authenticated in accordance with the laws of this State, **Nicholas Guadalupe Iracheta a/k/a Nicholas Guadalupe Iracheta, Jr. a/k/a Nick Guadalupe Iracheta a/k/a Nicholas Iracheta a/k/a Nicolas Guadalupe** (the "fugitive") was convicted by judgment and sentence of **felony Criminal Sexual Conduct in the 1st Degree**, and charged by a complaint warrant with **two counts of felony Predatory Offender – Knowingly commits act or fails to fulfill registration requirement**, which I certify to be **crimes** under the laws of this State, was present in the State of **Minnesota** at the time of commission of the crimes, has since been released on probation but failed to abide by the terms and has fled from justice in the State of **Minnesota**, is now a fugitive, and may now be found in the State of **Kansas**.

Now, Therefore, pursuant to the Constitution and laws of the United States, and the laws of the State of **Minnesota** and the State of **Kansas**, I hereby request that the fugitive be apprehended and delivered to **Cottonwood County Sheriff Jason Purrington** and/or authorized designee(s), who is/are authorized to convey the fugitive to the State of **Minnesota**, there to be dealt with according to law.
