Whereas, it appears by the attached supporting documents, which I certify to be authentic and duly authenticated in accordance with the laws of this State, **Ma’Narion Timothy Douglas Fuse, a/k/a Ma’Narion Timothy Fuse, a/k/a Manarion Timothy Fuse, a/k/a Timothy Manarion Fuse, a/k/a Manarion Fuse, a/k/a Manarion Timothy Douglas Fuse, a/k/a Manarion T Fuse** (the “fugitive”) was charged by complaint with **felony Receiving Stolen Property**, which I certify to be a **crime** under the laws of this State, was present in the State of **Minnesota** at the time of commission of the crime, but has since fled from justice in the State of **Minnesota**, is now a fugitive, and may now be found in the State of **South Dakota**.
