Whereas, it appears by the attached supporting documents, which I certify to be authentic and duly authenticated in accordance with the laws of this State, **Eleazar Ivan Salmoran** (the "fugitive") was charged by complaint with **eight felony counts of Burglary – second degree, three felony counts of Burglary – Third Degree, five felony counts of Possession of Burglary/Theft Tools, seven felony counts of Theft, two felony counts of Drugs – Third Degree, and one felony county of Drugs – Fifth Degree** which I certify to be **crimes** under the laws of this State, was present in the State of **Minnesota** at the time of commission of the crimes, has fled from the jurisdiction of the State of **Minnesota**, and is now a fugitive, and may now be found in the State of **Washington**.

Now, therefore, pursuant to the Constitution and laws of the United States, and the laws of the State of **Minnesota** and the State of **Washington** I hereby request that the fugitive be apprehended and delivered to **Clay County Sheriff Mark Empting, and/or authorized designee(s)** who is/are authorized to convey the fugitive to the State of **Minnesota**, there to be dealt with according to law.
