**WHEREAS** it appears by Judgment/Sentence, Recommendation of the Director of Anoka County Community Corrections Department and Order of the Court Vacating Stay of Execution of Sentence, Warrant and supporting documents, a copy whereof is hereunto attached and which I certify to be authentic and duly authenticated in accordance with the laws of this State, that **MARTHA LYNN McGUIGGAN aka MARTHA LYNN EASTBURN** stands convicted of the crimes of **Two Counts Controlled Substance Crime in the Third Degree**, committed in the County of Anoka in this State, which I certify to be crimes under the laws of this State, she being within this State at the time she committed said crimes and who, since conviction and release on probation has **FAILED TO ABIDE BY THE TERMS AND CONDITIONS OF HER PROBATION** and it having been represented and satisfactorily shown to me that said **MARTHA LYNN McGUIGGAN aka MARTHA LYNN EASTBURN**, since the commission of said crime has fled from the justice of this State and now is a fugitive from the justice thereof and may have taken refuge in the State of **ARKANSAS**;

**NOW THEREFORE** pursuant to the provisions of the constitution and laws of the United States in such case made and provided I do hereby request that the **MARTHA LYNN McGUIGGAN AKA MARTHA LYNN EASTBURN** be apprehended and delivered to **DAVE KEDING, Anoka County Deputy Sheriff, and/or his agent (s)** who is/are hereby appointed agent(s) to convey him to the State of Minnesota, there to be dealt with according to law.
