NOW THEREFORE pursuant to the provisions of the constitution and laws of the United States in such case made and provided I do hereby request that **BRYANT LEE MENGER** be apprehended and delivered to **DOUGLAS HODGE, Deputy Sheriff of the County of Chippewa, and/or his agent (s)** who is/are hereby appointed agent(s) to convey him to the State of Minnesota, there to be dealt with according to law.
