Whereas, it appears by the attached supporting documents, which I certify to be authentic and duly authenticated in accordance with the laws of this State, **Jath Joseph Vincent** (the "fugitive") was charged by complaint with **felony Assault – 1st degree – Use of Deadly Force Against Peace Officer/Prosecutor/Judge or Correctional Employee, felony Traffic – 1st degree DWI – Operate Motor Vehicle – Any Amount Schedule I/II Drugs/Metabolite, felony Fleeing a Peace Officer in a Motor Vehicle, felony Theft – Take/Drive Motor Vehicle – No Owner Consent, and felony Drugs – 5th degree – Possess Schedule 1, 2, 3, or 4 paraphernalia residual** which I certify to be **crimes** under the laws of this State, was present in the State of **Minnesota** at the time of commission of the crimes, has since fled from the jurisdiction of the State of **Minnesota**, and is now a fugitive, and may now be found in the State of **North Dakota**.

Now, therefore, pursuant to the Constitution and laws of the United States, and the laws of the State of **Minnesota** and the State of **North Dakota** I hereby request that the fugitive be apprehended and delivered to **Beltrami County Sheriff Jason Riggs, and/or authorized designee(s)** who is/are authorized to convey the fugitive to the State of **Minnesota**, there to be dealt with according to law.
