ORDINANCE NO. 1996-1

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MCKINLEY TO INCLUDE CERTAIN LAND OWNED BY THE CITY OF MCKINLEY AND ABUTTING THE CITY OF MCKINLEY

WHEREAS, the City of McKinley owns the following described property which abuts the corporate limits of the City of McKinley:

Southwest Quarter [SW $\frac{1}{4}$ ] of the Northeast Quarter [NE $\frac{1}{4}$ ];  
Southeast Quarter [SE $\frac{1}{4}$ ] of the Northeast Quarter [NE $\frac{1}{4}$ ];  
Northwest Quarter [NW $\frac{1}{4}$ ] of the Southeast Quarter [SE $\frac{1}{4}$ ];  
Northeast Quarter [NE $\frac{1}{4}$ ] of the Southeast Quarter [SE $\frac{1}{4}$ ]

all in Section 17, Township 58 North, Range 16 West of the 4th P.M.

WHEREAS, it is the desire of the City of McKinley to annex said abutting land to the corporate limits of the City.

NOW, THEREFORE, the City Council of McKinley, Minnesota does hereby ordain:

Section 1. The City Council hereby determines and finds that the property is unincorporated, it abuts the municipality and is owned by the City of McKinley. The City may annex said land by ordinance under the terms of Minn. Stat. §414.033 subd. 2(a). The property is not included in any area that has already been designated for orderly annexation pursuant to Minn. Stat. §414.0325.

Section 2. The land is urban in nature or about to become so.

Section 3. The corporate limits of the City of McKinley are hereby extended to include said property and the same is hereby annexed to and included within the City of McKinley as if the property had originally been part thereof.

Section 4. The City Clerk is directed to file certified copies of this ordinance with the Minnesota Municipal Board, Biwabik Township, the St. Louis County Auditor and the Minnesota Secretary of State.

Section 5. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 4 and approval of the Ordinance by the Minnesota Municipal Board.

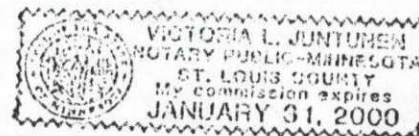
