ORDINANCE NO. 092-271

An Ordinance Amending Ordinance 092-265 by Correcting the Legal Description of the Unplatted Parcel of Land Owned by Lavane and Helen Bung to be Annexed from Empire Township

THE CITY COUNCIL OF THE CITY OF FARMINGTON HEREBY ORDAINS AS FOLLOWS:

SECTION I: The property described below is hereby annexed to the City of Farmington pursuant to Minnesota Statutes §414.033(5), to wit:

The East Eighty (E.80) feet of the following described tract of land, to wit:

All that part of the South Half of the Southeast Quarter (S½ of SE¼) of Section Thirty (30), Township One Hundred Fourteen (114), Range Nineteen (19), described as follows: Commencing at a point 40 feet north of the northwest corner of Lot 5 (5) in Block Two (2) of Bung's Addition, thence North 200 feet, thence East 320 feet, thence South 200 feet, thence West 320 feet to the place of beginning. Subject to and together with an Easement over the South 40 feet of the last described tract for road purposes.

SECTION II: The City Administrator is hereby directed to file certified copies of this Ordinance with the Minnesota Secretary of State, the Minnesota Municipal Board, the Dakota County Auditor and the Empire Town Board.

SECTION III: This annexation shall be effective at such time as this ordinance has been approved by the Minnesota Municipal Board and the ordinance has been published in the official newspaper.
