**NOW THEREFORE** pursuant to the provisions of the constitution and laws of the United States in such case made and provided I do hereby request that the said **CORY LEE SMAGLIK** be apprehended and delivered to **Deputy Sheriff Dan LaFee, and/or his agent (s)** who is/are hereby appointed agent(s) to convey him to the State of Minnesota, there to be dealt with according to law.
