

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Luverne and the Town of Luverne; and

WHEREAS, an amendment to the joint resolution was received from the City of Luverne and the Town of Luverne requesting that certain property be annexed to the City of Luverne pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on March 3, 1994 the Minnesota Municipal Board has reviewed and accepted the amendment to the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Luverne, Minnesota, the same as if it had originally been made a part thereof:


The East Thirty-Three Feet (E. 33') of the Southwest Quarter (SW 1/4) of Section Ten (10), Township One
