**AN ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE CITY OF DENT, COUNTY OF OTTER TAIL
TO INCLUDE CERTAIN UNINCORPORATED
PROPERTY ABUTTING UPON THE LIMITS OF THE CITY**

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city, village or borough; and

WHEREAS, the territory to be annexed is less than 60 acres; and

WHEREAS, this territory abuts upon the boundary of the City of Dent.

THE CITY COUNCIL OF DENT, MINNESOTA DOES HEREBY ORDAIN:

Section 1. Territory Annexed. The corporate limits of the City of Dent, Minnesota are hereby extended to include the unplatted property described as follows: Lot 1, Block 3, Thelke's Addition to Dent, Minn.

Section 2. Filing. The Secretary is directed to file certified copies of this ordinance with the Board of the Township in which the property is located, the Secretary of State, the County Auditor of the County in which the property is located and the Minnesota Municipal Board, pursuant to Minn.Stat. § 414.033, Subd. 2.

Section 3. Effective Date of Annexation. This ordinance is effective and final on the date of publication and filing, pursuant to Minn.Stat. § 414.033, Subd. 2.
