**NOW THEREFORE** pursuant to the provisions of the constitution and laws of the United States in such case made and provided I do hereby request that the said **MICHAEL GREGORY CHENARIDES** be apprehended and delivered to **Sheriff Douglas A. Qualley, and/or his agent(s)** who is/are hereby appointed agent(s) to convey him to the State of Minnesota, there to be dealt with according to law.
