WHEREAS, the Dakota County Board of Commissioners has evaluated the advantages and disadvantages of changing to a seven-member County Board.

NOW, THEREFORE, BE IT RESOLVED, That the Dakota County Board of Commissioners determines that it is in the best interest of Dakota County to increase the Dakota County Board to a seven-member governing body; and

BE IT FURTHER RESOLVED, That the Dakota County Board of Commissioners hereby announces its intention to expand to seven members effective January 1, 1993 and authorizes the development of seven County commissioner districts in accordance with M.S. 375.025; and

BE IT FURTHER RESOLVED, That this resolution be forwarded to the Secretary of State, the Dakota County Legislative Delegation, Dakota County cities and townships and other interested parties.
