Permits

All powers and duties of the Commissioner of the Minnesota Pollution Control to issue, reissue, modify, amend, transfer, and approve or disapprove requirements and submittals resulting from:

- permits, certificates, and/or certifications including air registration [Minn. R. 7007], solid waste, and aboveground storage tank facilities, and the powers and duties of the Commissioner under the statutes and rules governing these permits, certificates and/or certifications; and
- water quality permits, certificates and/or certifications including national pollutant discharge elimination system (NPDES) disposal system, sanitary sewer extension, disposal system permit no. 50580 issued to the U.S. Army Corps of Engineers, wastewater treatment facility operator, sewage sludge, Section 401 Certifications and the authority under Minn. R. 7001.1450, subp. 1C, and 7001.1460 to waive the Agency's authority to issue a Section 401 Certification, waste disposal facility operator certification, and waste disposal facility inspector certification; and the powers and duties of the Commissioner under the statutes and rules governing these permits, certificates and/or certifications.
- Certify underground storage tank (UST) owner/operators use of Statistical Inventory Reconciliation (SIR) as an alternative method of leak detection under Minn. R. 7150.0330, item I (tanks) and part 7150.0340, item C (piping).
- Approve methods of assessing underground storage tanks for corrosion holes which are no less protective of human health and the environment than methods included in Minn. R. 7150.

Such powers and duties are subject to Minn. Stat. § 116.02, subd. 6, and to my supervision and control, and to the supervision and control of the Municipal Wastewater Section, Municipal Division.

Enforcement

All powers and duties of the Commissioner of the Minnesota Pollution Control Agency for facilities to sign, issue, amend, terminate, and approve forgivable Administrative Penalty Orders, Schedules of Compliance, Notices of Violation, Settlement Agreements, Notices of Noncompliance, letters of warning, and to request information and issue request for information letters, perform inspections, collect information, examine records, and require recordkeeping, reports, monitoring, and testing, and regulate the UST and Aboveground Storage Tank enforcement programs pursuant to Minn. R. 7100, 7105 and 7150. Such powers and duties are subject to Minn. Stat. § 116.02, subd. 6, and to my supervision and control, and to the supervision and control of the Municipal Wastewater Section, Municipal Division.
