THAT PART OF THE SOUTHEAST QUARTER OF THE NORTHEAST QUARTER OF SAID SECTION 8, SOUTH OF A LINE 280 FEET NORTH OF THE SOUTH BOUNDARY LINE OF SAID SOUTHEAST QUARTER OF THE NORTHEAST QUARTER.

3. The area proposed for detachment is situated within the City of Ada and

abuts the common boundary between the city and McDonaldsville Township, Norman County.

4. The area proposed for detachment is rural in character and not developed for

urban residential, commercial, or industrial purposes.

5. The area proposed for detachment is approximately 4 acres and needs no municipal improvements.
