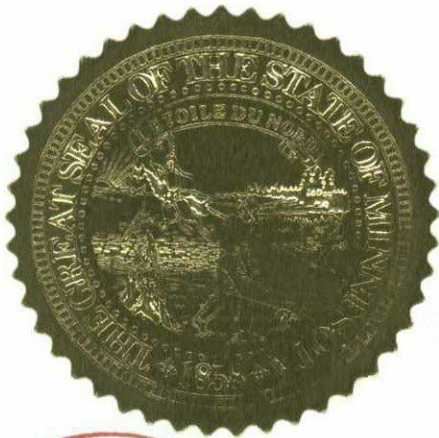

LISA A. FOBBE, having received the highest number of votes for State Senator District 16, is hereby declared elected.



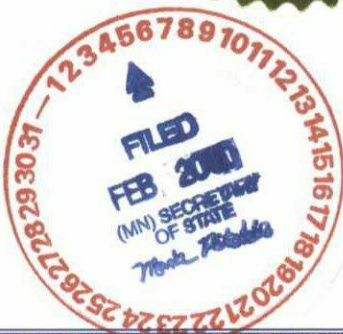
