**RESOLUTION APPROVING SPECIAL LEGISLATION
FOR CENTRAL IRON RANGE SANITARY SEWER DISTRICT**

WHEREAS, Representatives from the City of Hibbing, City of Chisholm, City of Buhl, City of Kinney, Town of Balkan, Town of Great Scott and Ironworld Discovery Center have been meeting to discuss the concept of a Central Iron Range Sanitary Sewer District; and,

WHEREAS, It has been determined that a Central Iron Range Sanitary Sewer District may be beneficial to the individual communities as well as for regional economic development and that further study is warranted; and,

WHEREAS, The legislation has the full support of Congressman Jim Oberstar, Senator David Tomassoni and Representative Tony Sertich; and,

WHEREAS, Grants for large scale projects such as the Central Iron Range Sanitary Sewer District are only now available for projects of regional or statewide impact; and,

NOW, THEREFORE, BE IT RESOLVED, that the City
of ~~the~~ Buhl does hereby approve the special
legislation for the Central Iron Range Sanitary Sewer District,
Minnesota Session Laws 2003, Chapter 128, a copy of which is
attached hereto, which legislation requires approval by the


