This bond is hereby amended as follows:



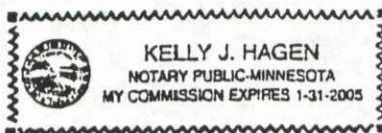
